GENERAL DISCUSSION

5. **AI-38076** Update on the Juvenile Mentoring Program, Commissioner Precinct 4.

Commissioner Webb introduced Marina de la Garza, JLCC (Junior League of Collin County) President, and Angie Sifferman, President Elect. The Commissioner explained the JLCC is a 900-member volunteer women's group based in Collin County which was established in 1976. Since its inception, the JLCC has contributed over 750,000 hours of volunteer service to the County and over \$6 million toward community projects. Some of the most notable projects started and implemented by the JLCC are the Volunteer Center of Collin County, Collin County Children's Advocacy Center, Hope's Door, Turning Point, Sci-Tech Discovery Center in Frisco and the Collin County Council on Family Violence.

Ms. Garza came forward to present a Power Point presentation on the Junior League's newest program JUMP (Juvenile Mentoring Program). JUMP was researched and developed extensively for two years. Research into several Junior Leagues across the country revealed that this extensive type of project did not exist. The JUMP volunteers work in conjunction with officials at Collin County Juvenile Probation. These volunteers serve as mentors and conduct monthly training sessions in a classroom environment with the juveniles at the McKinney Juvenile Facility. The goal with JUMP is to utilize the trained women of the JLCC and train these juvenile offenders with life skills and tools with the goal of reducing recidivism. Pam Huffman, Director of Juvenile Probation, and Lynn Hadnot, Assistant Director, select the kids they believe will benefit most from the program.

There are six monthly curriculum sessions which include one-on-one mentoring. The curriculum has been researched and developed specifically to address issues for at-risk youths such as Media Literacy, Boundary Setting and Building Healthy Relationships, Assertive and Effective Communication, Managing Negative Emotions, and Positive Self Image. The objective is to implement a positive role model in a positive setting for juveniles in the probation system for non-violent, first offense crimes. Each juvenile must complete the cycle of sessions and upon completion there is a graduation ceremony and plaque presentation to honor their achievement. The program accepts both male and female participants between the ages of 12 and 15. Successful completion of this program is brought to the attention of the Juvenile Judge.

The program is self-funded and run by the JLCC. Ms. Garza thanked Ms. Huffman and Ms. Hadnot for opening the doors and giving the program a chance. The hope is to grow the program and bring it to other cities in Collin County and help put these youths on the right track so they don't become adult offenders. (Time: 1:42 p.m.)

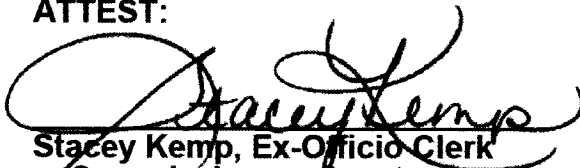

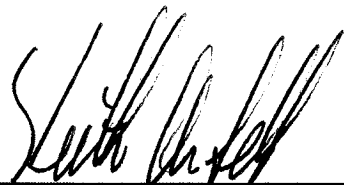
EXECUTIVE SESSION

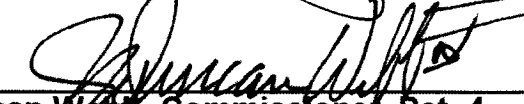
