Earl Holloway has offered to purchase 2738 Windmill Drive, (BEING LOT 24, WINDMILL ESTATES ADDITION, 2738 WINDMILL DRIVE, COLLIN COUNTY, TEXAS, AS RECORDED IN VOL. 2498, PAGE 404 OF THE COLLIN COUNTY DEED RECORDS) for \$7,200.00.

This property was sold at a Sheriff's Sale on August 7, 2007 pursuant to delinquent tax collection suit number 401-00567-06. There were no bidders and the property was struck off to the Collin County Community College District for itself and on behalf of the other taxing jurisdictions.

The property's most recent value according to the Appraisal District is \$20,000.00. The property was struck off for the assessed value in the Judgment, \$15,000. The total judgment amount was \$22,662.67 which includes taxes, penalties and interest, costs of court, and costs of sale.

Pursuant to the Texas Property Tax Code the court costs and costs of sale must be paid first out of the proceeds of a resale. The remainder would be distributed to the taxing jurisdictions pro-rata. Those costs total \$3,585.15. A breakdown of amounts each taxing entity will receive is enclosed.

In addition, the County has a road assessment lien on the property which will be extinguished by this sale. Pursuant to the Texas Property Tax Code, this lien is only paid if there are excess proceeds after all entities are paid the full amount of taxes due.

If all taxing jurisdictions agree to accept \$7,200.00 for the property, the property may be sold for that amount. Each jurisdiction must execute the deed.
