Commissioner Webb pulled this item to ask why conference fees are being paid out of the District Court Shared Miscellaneous account for one judge to attend and speak at a conference. Jeff May. County Auditor, stated that Judge Roach, as the administrative judge, was asked to speak at the conference. Judge Roach felt the fees should be paid from the shared account since he did not have monies budgeted in his department for this conference. The Commissioner suggested moving the monies into Judge Roach's budget in order for his budget to reflect the impact rather than paying the conference fees directly out of the shared account. Monika Arris, Budget, stated the budget adjustment could be adjusted for monies to be moved from the District Court Shared budget into Judge Roach's departmental budget to pay the fees. Judge Self asked if all the district judges signed off on this request. Mr. May stated the impression he was given by Judge Roach was the judges were in agreement but he was unsure if they voted on the issue. Mr. May went on to say the way the shared budget is usually handled is the administrative judge is the responsible party for the budget. There was a brief discussion on whether approval of the item as is would set precedence for future requests. A motion was made to move monies from the District Court Shared budget into Judge Roach's budget in order for conference fees to be paid out of the Judge's departmental budget. (Time: 1:52 p.m.)

Commissioner Webb stated there were several action items on the agenda. One interesting item was the Federal Transit Administration Funding Changes. There has been a change on how transit is funded at the federal level. Budget allocation within the region is still 72% to the east and 28% to the west. The change is for non-traditional non-profits who can apply for grants to have access to 2% of the budget amount instead of all the funding going to the transit agencies. An example of an eligible non-profit is Meals on Wheels. They could apply for a portion of the 2% for transit purposes including infrastructure, job access and reverse commute.

The Commissioner stated another item of interest was the June 2014 Unified Transportation Program Updates-New Texas Department of Transportation Funding. The reason this item was interesting is Collin County had no items on the list. At this time the County has no projects ready. The projects that are on the list are large; therefore, Collin County needs to get more of the large projects going in order to be eligible for transportation funds.

The Commissioner said the Environmental Speed Limit Transportation Control Measure Substitution will be up for approval at the next meeting. The vote will be to reverse the five-mile-per-hour speed limit reduction put in place years ago on all highways going into Dallas/Fort Worth. The speed limit reduction was to reduce air pollution. Because vehicles are more efficient now, higher speeds do not pollute the air. The vote will be to increase the speed by five miles per hour or higher if the Texas Department of Transportation deems it safe to do so.

The last item of interest was the Bicycle/Pedestrian User Count Program Launch. NCTCOG (North Central Texas Council of Governments) will lend equipment to municipalities or counties to count bicycle and pedestrian traffic on trails to determine if monies are being utilized in those areas. Six trails will be monitored in Plano. Plano will supply equipment for four of the locations and will borrow equipment for the other two from NCTCOG. (Time: 2:01 p.m.)

Judge Self would like to see the Engineering Department's review of the Program Transportation Funding since 2007 when it was agreed upon to toll State Highway 121. Judge Self also added to the next agenda the 2015-2018 Transportation Improvement Program for North Central Texas that was approved by the RTC (Regional Transportation Council), specifically the approval of US Highway 75 tolling gantries. 
## **EXECUTIVE SESSION**
