Caren Skipworth, CIO, explained the objective for this project is to install Phase I of the security cameras for FY2014. This also includes Phase II in FY2015. Phase I will include interior and exterior security cameras for seven facilities. Two buildings, JJAEP (Juvenile Justice Alternative Education Program) and the courthouse, are being funded with bond money. The courthouse consists of two interior cameras for each active courtroom as well as four build-out courtrooms. Ms. Skipworth is asking the Court to consider approval to recommend award on this item.

Judge Scott Becker, 219th District Court, speaking for the Board of District Judges, stated the District Court had some statutory concerns regarding recording devices in the courtroom but those were adequately addressed by IT. Judge Becker came to answer any questions the Court might have.

Judge Corinne Mason, County Court at Law 1, explained County Court judges were not included in the initial meetings. The County Judges voted and decided they do not need or want the security cameras. However, the County courtrooms have pads on both the inside and outside for access. The pads in the back are not activated, allowing anyone to enter the courtrooms from the back. The County Judges feel that is an eminent threat and would prefer to have the pads activated rather than installing security cameras. Judge Self said the issue of the security pads being activated would be a future agenda item. Judge Mason also stated the County Courts have a standing policy of no cameras in the courtroom.

Judge Self asked Ms. Skipworth why the County Court judges were not asked about the cameras initially. Ms. Skipworth explained the funds were in the project for over five years and IT assumed the project two years ago. A project team was then formed and Pam DeVault, Court Administrator, represents both County and District Courts. Ms. Skipworth was not aware of the no camera policy until she received Judge Mason's email. Judge Mason said none of the County Administrative judges were contacted regarding these cameras.

Dr. Kelley Stone, Homeland Security, said this started five years ago and was discussed in detail with former Administrative Judge John Barry. It had also been discussed at several courthouse meetings since that time and was assumed the communication was going to everyone since that is the purpose of the Courthouse Security Committee. Dr. Stone apologized for the oversight. Judge Mason explained this process started before Ms. Skipworth or Ms. DeVault were involved.

Ms. Skipworth, in addressing Judge Mason's concerns, said the system has the ability to have covers put over the cameras much like a lens cover. Other options are not connecting the cameras to the network, connecting the cameras but reconfiguring them based on the judges' needs or removing the cameras from the County courts. There was a brief discussion on having commonality within the courtrooms while reconfiguring the cameras to meet the needs of the current judges.

Commissioner Webb wants the judges to specifically ask for the disabling of the cameras so, if an incidence does occur in their courtroom, they will have to deal with the repercussions of having no cameras in the courtrooms.

Judge Paul Raleeh, Justice of the Peace, Precinct 1, wanted to clarify that funding for cameras used in the Justice Courtrooms would come from the Justice Courts Security Fund. These are fees paid by defendants which can only be used for Justice Court security. A motion was made to approve the item. (Time: 1:57 p.m.)

Commissioner Webb pulled this item because it is a large amount of indirect taxpayer money. The Commissioner spoke with Greg Hudson, Legal Counsel, and proposes to take \$40,000 of this money and distribute it to the CAC (Children's Advocacy Center) which is allowed by statute, and take the remaining \$157,368 and use this to offset the cost the County spends supporting the libraries.

Commissioner Hill pulled this item because it is the second time it is on the agenda and was to be brought back with a range of options as to what could be done with these funds. The Commissioner wanted a fuller response as was requested. Bill Bilyeu, County Administrator, explained the statute is very specific as to how the money can be used. Mr. Bilyeu did get clarification from Mr. Hudson that they could not go backwards with TIRZ (Tax Increment Reinvestment Zone) to offset those funds. Commissioner Webb said it could be done prospectively to offset future costs.

Judge Self asked what determines this huge payment and is there any expectation that this large payment will continue into the future. Mr. Bilyeu said there was no payment received last year and this is an anomaly compared to past years. In the past it has been approximately \$30,000 a year but it is difficult to forecast. These are unclaimed electric co-op deposits. Commissioner Hill asked if the funds could be held and distributed over time. Mr. Bilyeu confirmed there was no timeframe requirement but the funds could only be used for purposes listed in the statute. A motion was made to approve Commissioner Webb's proposal to distribute \$40,000 to CAC and the remainder to offset the libraries' subsidies. (Time: 2:05 p.m.)
