








# Road & Bridge Fund Budget: Five-Year Trend






#### **Road & Bridge Fund Actual**






#### **Operating Funds Budget: Five-Year Trend**








## **Combined Budget: Five-Year Trend**

#### **Items for Consideration**

- County Auditor Increase of \$1,950
  - 1st Assistant Auditor PFP increase from 3.19% to 5%
- Permanent Improvement Fund Increase of \$22,500 for Courthouse doors
- Badge Project Increase of \$75,000
- Elections Expansion
  - Increase of \$424,000 for rent, utilities, finish-out, and FFE
- Indigent Defense Increase of \$220,000 in Court Appointed Attorney



#### **Items for Consideration**

- County Court at Law 4 Increase of \$415
  - Transaction Counter for Bailiff's Desk
- District Attorney Decrease of \$1,884
  - Change request to 22 phones from 24
- Commissioner Pct 1 Decrease of \$8,239
  - Salary and benefit increase accidentally duplicated

  - Judge Raleeh, JP 1: Increase salary to \$98,000 approved by vote of 6-3 (Increase of \$3,237 to Proposed Budget)
  - Judge Douglas, JP 2: Increase salary to \$98,000 approved by vote of 7-2 (Increase of \$3,237 to Proposed Budget)
  - Judge Ruckel, JP 3-1: Increase salary to \$98,000 approved by vote of 6-3 (Increase of \$3,237 to Proposed Budget)
  - Judge Yarbrough, JP 4: Increase salary to \$98,000 approved by vote of 6-3 (Increase of \$3,237 to Proposed Budget)
