Due to rising production costs, the manufacturers are unable to hold the prices that we have had on the Roses 1148 toilet tissue and the StefcO center pull towels for the last two years. Attached you will find manufacturer's letters of increases on these two items. We will need to raise the prices on these two items by 5% on each item. This will make your new toilet tissue price \$18.90 from \$18.00 and the new center pull price \$20.31 from \$19.34. The price on the powdered cleanser has not changed. These prices will be held firm for the new contract period.

Effective close of business July 11, 2014 Sofidel America will increase prices up to 10% on all Away from Home products including towel, tissue, napkin products and dispensers.

This increase is necessitated due to sustained cost increases in pulp, energy and raw materials.

Contracts for end users and national accounts will be increased up to 10% per terms and agreements of the contracts.

All orders received by July 11, 2014 calling for shipment by July 31, 2014 will receive current pricing. Orders received after July 11, 2014 will be invoiced at the new announced pricing. Orders are subject to a limit of 1/12th of your annual purchases.

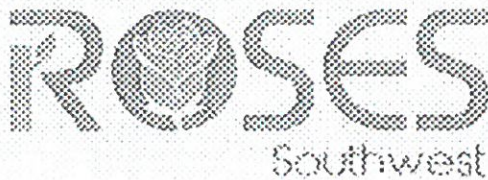
New price lists will be mailed to you by May 30th 2014.
