GENERAL DISCUSSION

5. Al-39024 Reclassification of Functional Analyst, Human Resources.

Cynthia Jacobson, Human Resources, stated, after a re-review of the standards and job duties being performed by the Functional Analysts, the recommendation is to keep the position in its current classification. Commissioner Williams asked why she would use the information on the PFP (Pay for Performance) versus the job description. Ms. Jacobson said the job description is a general outline of the job expectations while the PFP shows actual duties performed during the year. The PFPs for all of the Functional Analysts were reviewed. Commissioners Webb and Williams were comfortable with the recommendation from HR.

Commissioner Reid asked if there was a difference in the duties of the Functional Analyst from department to department. Ms. Jacobson said the duties performed did vary significantly, but the concept is that they will all be doing similar duties. It is a new position and no other local county has a similar position. Currently, several of the Functional Analysts are not doing full-time work in that capacity. Ms. Jacobson said the position may evolve over time but it does not make sense to reclassify it at this time. (Time: 1:39 p.m.)

Commission Webb said the main discussion of the RTC (Regional Transportation Council) meeting was regarding the Blacklands Corridor and the two public hearings. There was a discussion to determine the next steps in putting the corridor into the Mobility Plan. This will be an action item next month. It was stressed that the corridor study is showing there is a need but it is not a recommendation of a specific route as to where the road is to go. TxDOT (Texas Department of Transportation) and an environmental process will determine where the road would go if there is a road.

There were some TIP (Transportation Improvement Program) modifications approved and some TAP (Transportation Alternatives Program) project selections were approved. Four of these TAP projects are in Collin County with approximately \$25 million allocated amongst these projects.

Commissioner Webb moved that item 3 under FYI Notification on the Commissioners' Court agenda be postponed to next month in order to get some input from the Court. The Commissioner would like the Court's thoughts relating to the big four, the legislation to support, and what should be monitored relating to transportation. The Commissioner will need to have the Court's concerns and/or comments by the middle of next week.

The RTC approved an MOU (Memorandum of Understanding) among the City of Mesquite, DART (Dallas Area Rapid Transit), STAR Transit and the NCTCOG (North Central Texas Council of Governments). DART is moving away from the model of pay to play and the Commissioner would be interested to see if DART goes to a different model in terms of providing transit services for contract without an election. The Commissioner wanted to know if the two-year period was being waived but did not see that in the MOU.

Judge Self referenced an article suggesting the staff may change their recommendation on the Blacklands Corridor and asked Commissioner Webb if this was discussed during the meeting. The Commissioner said there was nothing said about a change in their recommendation. (Time: 1:46 p.m.)

Commissioner Williams wanted to discuss this because the NTBHA (North Texas Behavioral Health Authority) Board will have a special meeting this Wednesday and the Commissioner needs feedback from the Court on this issue. The Sunset review of HHSC (Health and Human Services Commission) for the State of Texas had a section specifically addressing NorthSTAR which Collin County and six other counties participate in for handling mental health. The Sunset review addressed many of the Court's concerns though this did not appear to be the consensus of the NTBHA Board. The Commissioner feels there is an opportunity to do something different than NorthSTAR and still have money flow with it which has been the biggest concern about leaving NorthSTAR. Commissioner Williams was surprised at the tone taken by the NTBHA Board which was a bit defensive. There was a sense that the Board would prefer to stay in the status quo. Also Dallas County has done a resolution indicating the same.

Randy Routon, Ph.D., LifePath Systems, said the discussion regarding the Sunset report was interesting because several people were very animated about their support for continuing. Dr. Routon feels the report is very accurate and he thinks this is an opportunity for Collin County to get a fair share of the funding in order to continue to have competition among providers. The report recommends continuing to have competition among providers and also adds competition among plans. Currently, there is only the ValueOptions Plan. Across the country, most have two managed care companies that compete for the clients. The clients should be able to choose which plan they want. The proposal under the recommendation would do that because it would go to the big HMO (Health Maintenance Organization) plans.

Commissioner Williams said the state has not laid out exactly how it wants NorthSTAR to change and the Court needs to come up with a model to sell to both the legislature and to HHSC. Dr. Routon said there are state rules with regard to offering state-funded services in your area. There needs to be an authority and some public entity that can make decisions about how resources are spent. This new authority would be mandated with providing services through providers and also have some ability itself to take care of emergencies. There also needs to be a plan. The plan and the authority are the two items that would need to be approved by the state.

Commissioner Williams said the report from staff indicates the biggest issues are the blended funding which they are now taking steps to eliminate. This is where they take dollars from both Medicaid and indigent which is technically against the rules. In Dallas County, patients that are eligible for both Medicaid and NorthSTAR are being moved out of NorthSTAR and into a regular HMO. In 2016 kids will be moved into the STAR kids program. More and more money is being shifted to the HMOs. The state is already moving to make those changes.

The other thing is DSRIP (Delivery System Reform Incentive Payment) and the inability for NorthSTAR to participate with DSRIP projects on the 1115 Waiver because it is a private company and not a public authority. The Commissioner's recommendation would be, since Dr. Cruser and PIA (Public Information Associates) have been involved in the mental health assessment and the 1115 Waiver, to ask Dr. Cruser to help create a plan and work towards talking points to take to both the state and the legislature during this session.

Commissioner Webb agrees with Commissioner Williams and would like to do a resolution supporting wiping NorthSTAR out and going back to an integrated model using Dr. Cruser to come up with a proposal. Judge Self said the Court will need legislative language.

There was a brief discussion regarding integrated healthcare. Judge Self said Collin County needs more services and asked if a model can be designed that is attractive enough to providers to provide the services we need in Collin County. Dr. Routon said that could be done. Commissioner Williams wants to expand this and include a model that the Court would propose.

Judge Self told Mr. Bilyeu the contract with PIA will need to be changed with instructions to go through the RHP to do the integrated model. Dr. Routon said there are two pieces to this and the Sunset recommendations which will be voted on November 14th or 15th of 2014. If the Court wants to do this, it will need to support the recommendation. Then there will be a year or two to design the model. Commissioner Williams stressed the Court needs a resolution by next week in support of the Sunset Committee's recommendation. (Time: 2:04 p.m.)
