Ms. Homfeld said, according to the current subdivision regulations, this road can be a public roadway. Commissioner Hill asked if the Court has a duty to approve this since all of the regulations and statutes have been met. Ms. Homfeld said that was correct. Judge Self said the photogrammetry process that he had mentioned last month was approved and the Judge did vote for it. Approximately \$600,000 has been spent so far for both equipment and training and the photogrammetry equipment will be going to the cities along the major highways. There was nothing else of major consequence on the Board's agenda. (Time: 1:46 p.m.)

9. <u>AI-39099</u> Consideration to oppose the RTC Legislative Agenda Item seeking toll authority for 7 highways, County Judge.

Judge Self explained the RTC (Regional Transportation Council) passed a legislative agenda item that included asking the legislature for the authority to toll seven highways in the region. The environment in Austin is more positive than the Judge has ever seen it and many candidates statewide have come out against adding tolls in the state. The legislators are talking to each other about how to do that with one option being vehicle sales taxes going to fund transportation. The Judge does not think we should send mixed messages in our legislative agenda item to Austin. If there is a chance for true transportation reform, we then should not be asking for the back-up which is the authority to toll seven more roads. This is one of those examples where the citizens, not the politicians, have lead the way in stopping the tolling on the HOV lane on US 75 and the Blacklands Corridor. We owe it to the citizens to try to encourage the legislature to return to a more historic percentage of the state budget funding transportation.

Judge Self read from Chapter 391 of the Local Government Code stating that a commission may plan for the development of a region and make recommendations concerning major thoroughfares, streets etc. It also states that a plan or recommendation of a commission may be adopted in whole or in part by the governing body of a participating governmental unit. Therefore, the Judge's recommendation is that the Court state that it is opposed to this mixed message and that we ask our legislators to come up with a plan to fund transportation adequately in the state of Texas.

Commissioner Hill agreed that the citizens have spoken strongly against tolling and feels that this is an opportunity to speak with one mind saying we expect the state to help us and would not like to see movement towards more toll roads.

Commissioner Webb was unsure as to what the seven toll roads were. The back-up referenced seven CDA (Comprehensive Development Agreement) projects, all of which have been approved by the state legislature with none of these seven projects impacting Collin County. The Commissioner does not want to get into the middle of other counties' affairs. Judge Self said we are a participant in this region, not a subset of Dallas and Tarrant Counties. The RTC has 44 members and Collin County is routinely outvoted in the RTC in terms of dollars. Collin County needs to lead not just for our region but for the whole state.

The Judge said the state budget needs to be reprioritized and, with the change in the environment in Austin, feels this would be the right time to encourage the legislature to adequately fund transportation. Commissioner Webb agreed that Collin County is outvoted all the time. There was a lengthy discussion about the Judge's recommendation potentially jeopardizing the funding for the seven CDAs and alienating the other 43 RTC members.

Commissioner Hill supports Judge Self's recommendation and would like a unified approach to opposing tolling. Commissioner Webb said these are regional roads and the state should fund them since they benefit the region and the whole state. Moving commerce through DFW to Houston or Austin is a state benefit to everyone. Commissioner Reid said a few years ago the economy of the Greater Dallas/Fort Worth metroplex was equivalent to 1/6 of the economy of China and 1/3 the economy of India. This is a huge economy and he agrees with Commissioner Webb entirely that transportation is critical to the continued growth of the economy. Transportation of goods and services contributed to the prosperity of this country. It is important that the legislature gets back to funding transportation as it has done historically. It is important to send a message to the legislature to fix transportation funding and oppose additional tolling. The Commissioner does not feel this will affect other regions' abilities to complete their roads. For those reasons Commissioner Reid also supports the Judge's recommendation.

Commissioner Webb opposes this and hopes this does not jeopardize funding on US 75 and the Outer Loop. However, the Commissioner said if the recommendation is limited to future CDAs he would support it because he is not in favor of public/private partnerships which include the element of profit. There was a brief discussion regarding the CDAs which have already been approved by the state legislature and whether the Judge's recommendation would affect them.

Judge Self suggested amending the Court Order to read, "Thereupon, a motion was made, seconded and carried with a majority vote of the Court to oppose any Comprehensive Development Agreements not already authorized and signed."

Commissioner Webb suggested omitting the word "signed" since all of these CDAs have been authorized but may not yet be signed. A motion was made to change the wording to "Thereupon, a motion was made, seconded and carried with a majority vote of the Court to oppose any Comprehensive Development Agreement not already authorized by the state legislature." (Time: 2:22 p.m.)
