On Monday, January 5, 2015, the Commissioners' Court of Collin County, Texas, met in Regular Session in the Commissioners' Courtroom, Jack Hatchell Collin County Administration Building, 4th Floor, 2300 Bloomdale Road, City of McKinney, Texas, with the following members present, and participating, to wit:

1. Judge Self called to order the meeting of the <u>Collin County Commissioners' Court</u> at 1:30 p.m.

President Self called to order the meeting of the <u>Collin County Health Care</u> <u>Foundation</u> at 1:56 p.m. and adjourned the meeting at 1:56 p.m.

Judge Self said this was the first audit of the County's collection program and there were no findings. Jeff May, Auditor, said the audit consisted of the District and County Clerks' offices and all of the JP (Justice of the Peace) offices. If any one of those offices had failed the audit, the County would have failed the audit. Mr. May was very pleased that all of the offices passed the audit which is not the case in many other counties. The OCA (Office of Court Administration) performed this audit because the Comptroller's Office did not want to do it and because this is an audit of court collections which is the OCA's concern. Rachelle Campbell, Family Nurse Practitioner from McKinney, came forward to talk about her family practice clinic, Trinity Family Health Center, and her lease signed in September of 2013 for Suite 280 at 900 E. Park Boulevard in Plano. Ms. Campbell was told that approximately two weeks of minor construction would take place. During this construction mold was discovered and the two weeks has turned into 15 months. As of today there is no known completion date for the construction in the building.

The construction delay has been a detriment to Ms. Campbell's business and after 13 months she temporarily relocated the business. This health center serves over 3,000 indigent patients in Collin County. After consulting with legal counsel, Ms. Campbell believes a reasonable settlement would be approximately \$80,000 and paperwork and receipts have been submitted for \$30,000 in actual physical damage. The County has offered \$3,000 for reimbursement of the rental deposit and \$700 for damages. Ms. Campbell said other damages include recurrent interruption of business and the fact that 50% of the space is unusable. The County did decrease the rent accordingly. Ms. Campbell stated she has not yet responded to two interview requests from the media in the hopes that an amicable resolution can be reached by January 15, 2015. (Time: 1:36 p.m.)

Judge Self recognized Mary Worthington, Administrator of CCF (CoServ Charitable Foundation) which is the philanthropic arm of the CoServ Electric and Gas Cooperative. The Judge then asked Sheriff Terry Box if he would accept the grant from CCF.

Ms. Worthington explained the grant is to protect law enforcement officers with the purchase of bulletproof vests. CCF is extremely committed to keeping first responders safe as they work to keep the community safe. The grant is in the amount of \$12,719 and comes from members and customers of the CoServ Electric and Gas Co-op. In 2014, the CCF gave away over \$800,000 in grants to the CoServ area.

Sheriff Box accepted the grant and said CCF has presented grants for the past several years to Collin County's law enforcement and expressed thanks on their behalf. (Time: 1:33 p.m.)

Judge Self questioned the numbers in the Court packet. Trial was requested by 26% of the 367 refusal cases and 68.1% with no BAC (Blood Alcohol Content) evidence were acquitted. When looking at the cases where BAC evidence was available, 428 requested trials with 50.7% being acquitted. The Judge asked Bill Bilyeu, County Administrator, to take a look at the numbers and costs since we are acquitting more than 50% of the cases with BAC evidence.

Judge Self also questioned the objective of obtaining a 90% minimum conviction rate on all DWI cases and wanted to make sure it was a 90% conviction rate on people who warranted it rather than an absolute conviction rate. With no further comments, a motion was made to approve the item. (Time: 1:43 p.m.)

GENERAL DISCUSSION

5. <u>Al-39301</u> Presentation of Sheriff's Office – Inmate monthly/quarterly statistics, Budget.

Sheriff Terry Box came forward with a Power Point presentation on his quarterly statistics. The first slide showed the total inmate population (jail and minimum security) averages for the past five years. There was a significant drop in the jail population following 2011 which the Sheriff attributes to the District Attorney's Office and court system. The female population for the past five years has averaged between 14% and 18%.

Sheriff Box explained a graph which showed no female population for a two-month period which was due to consolidating one minimum security female pod with a main jail female pod. This allowed the opening of one additional pod in the main jail which was needed due to an increase in the male population. This reduced both overtime and the need to hire more people.

There are 866 beds in the main jail, 24 beds in the jail infirmary and 192 beds in minimum security. No housing clusters or pods have been added since 2007 and the Sheriff doesn't think more beds will be needed for the next two to three years. There are 216 beds available in the intake and transfer area that could be used temporarily.

Sheriff Box explained that a few years ago during budget, he gave up six positions. Due to the current amount of overtime, the Sheriff may ask for those positions back. The Sheriff also mentioned a recent budget adjustment of \$286,451 in SCAAP (State Criminal Alien Assistance Program) funds to be used to cover the cost of FY 2014 overtime, training and travel.
