1. Judge Self called to order the meeting of the <u>Collin County Commissioners' Court</u> at 1:30 p.m. and recessed the meeting at 1:59 p.m. The meeting was reconvened at 2:00 p.m. and immediately recessed into Executive Session. The meeting was reconvened at 2:34 p.m. and adjourned at 2:34 p.m.

Judge Paul Raleeh, Justice of the Peace, Precinct 1, thanked the Court for the opportunity to have the visiting judge system. This will save money in the future with the expansion of courts because it allows the current courts to remain covered avoiding stalled cases. The two appointees were selected by the five sitting JPs (Justices of the Peace). The JPs know Judge Paz and Judge Thathiah and feel the two would be excellent additions to the system. Judy Florence, Parks Manager, came forward to request a public hearing for the consideration and issuance of a "Mass Gathering" permit for the 2015 Garden Show event on March 21-22, 2015. Ms. Florence stated this is the third application from the Master Gardeners and will be the fifth annual Garden Show. Judge Self opened the public hearing at 1:43 p.m. and asked for comments. Hearing none, Judge Self closed the public hearing at 1:43 p.m. A motion was made to approve the item. (Time: 1:43 p.m.)

6. <u>Al-39485</u> Presentation of Myers Park/Farm Museum month/quarterly statistics, Budget.

Judy Florence, Parks Manager, reviewed statistics for Myers Park and the Farm Museum. The first chart showed a steady increase in the Myers Park rental revenue. As of the end of January 2015 \$88,337 has been collected for FY 2015. This was due to a slight increase in revenue and fees from an increased number of events. There was a spike in March 2014 resulting from the new requirement of paying rental fees 90 days prior to an event.

Judge Self asked what percentage of the revenue was generated from The Landing. Ms. Florence said the majority of the revenue was from The Landing because it is the most used facility with an open space area of 3,000 square-feet.

The next chart reviewed was park event attendance. There was a spike in October and November with several new activities taking place. There were three cross country meets that brought in approximately 4,500 people. Other new events held during this period included: a Color Up 5K run, AgriLife Extension's heifer sale and annual bulb sale, several trainings held by County departments as well as camping by the Boy Scouts and Girl Scouts. Wedding related events also added to the increase of attendance in October with an average of five events every weekend. The three-day Vintage Market Days event was added in November bringing in approximately 6,000-8,000 people. The Imagine International Academy of North Texas held a symposium bringing in 500 people and the CUBE Cub Scout event brought in 350 people. December attendance increased due to a two-day gun show with 400 people, a Barn Hunters event with 300 people and a company party with 300 people. Attendance was also increased by the AgriLife classes and livestock shows. Judge Self asked what percent of events are public events as opposed to private events. Ms. Florence stated the attendance is approximately 60% private and 40% public.

Ms. Florence reviewed the number of events held. There were 110 events for the first quarter of FY 2015. The busiest quarter for Myers Park is the spring quarter. In 2014, The Landing held five parties, 10 high school banquets and 26 weddings during the spring quarter. The Poll Barn held eight parties, five high school banquets and six weddings during the spring quarter. These numbers are expected to increase.

The next chart reviewed was the number of calendar days park facilities were used. The Landing continued to be the most used with the Gazebo/Perennial Garden a close second. There was a decrease in usage days for the Pole Barn and an increase of usage days for Myers Woods from FY 2013 to FY 2014 with the completion of the restroom facility. The three week Boy Scout camp shifted to Myers Woods at that time.

Ms. Florence reviewed the Farm Museum visitor and participant numbers. There was a spike for visitors in 2014 due to displays loaned out to stores and libraries. Currently, items are displayed at Tucker Hill and Celina Light Farms and will soon be displayed at Haggard Library in Plano. The Farm Museum revenue is up in the first quarter of 2015 which is beyond the total for 2014. This is due to exhibit fees from Tucker Hill and Celina Farms, group tours and workshops. Commissioner Hill asked if the number of visitors to the libraries and stores include all the visitors coming through those locations or are they specific to viewing the displays. Ms. Florence said the numbers include all visitors coming into those locations. It is hoped the visitors are stopping to look at the displays. The displays do note they are from the Farm Museum.

The final chart reviewed was the safe event set up and tear down. The grounds crew is required to set up and tear down every event held at Myers Park. The ground crew also completes special projects in three areas: 1) projects with facilities; 2) projects with outside groups; and 3) internal projects. (Time: 1:58 p.m.)
