GENERAL DISCUSSION

5. AI-39687 Addition of Meals on Wheels to the Juror Option, Commissioner, Precinct 4.

Commissioner Webb asked Ray Ricchi, Chairman of Meals on Wheels Collin County, to come forward and explain why they should be added to the juror option. Mr. Ricchi introduced Dora Murphy, a client of Meals on Wheels, and asked her to give a background of the program from her perspective. Ms. Murphy, Westminster, said Meals on Wheels delivers a warm meal every day that she would not otherwise have. They also take care of other needs Ms. Murphy may have. Meals on Wheels cooks and delivers over 1,000 meals a day and she would like to do her part to help bring in donations. They also provide wheelchairs, walkers, toilet extenders, clothing, blankets, fans and heaters for people that have no other help. Ms. Murphy will be 81 years old, and Meals on Wheels is her life and her family.

Mr. Ricchi then introduced Arlo Rolandson, Plano, who used to volunteer with Meals on Wheels and is now a client. Mr. Rolandson said Meals on Wheels is keeping him alive by providing nutritious meals. Not only are the meals good and healthful, but they are delivered by people who care.

Jack Lodge, a volunteer, came forward next to thank all the people who work in the office and the kitchen of Meals on Wheels. His route consists of nine people, and they are very thankful for Meals on Wheels.

Mr. Ricchi introduced and thanked the kitchen staff, social workers and case workers who came to Court to support this agenda item. There is no cost or minimum income required for clients to participate in Meals on Wheels. This is an organization that tries to get people back on their feet and many times clients become volunteers when they have recovered from an illness or medical procedure. Shelf-stable meals are also provided for emergencies when weather prevents the volunteers from delivering meals. They also work with local municipalities to check on at-risk clients. Meals on Wheels not only provides meals, but is also a full-service senior operation.

Mr. Ricchi thanked the court for its help with funds from the general fund and asked to be one of the new boxes on the jury selection sheet as an option for a juror to donate their daily stipend. Judge Self said the county's annual support for the Agency on Aging and Meals on Wheels is close to \$50,000.

There was a brief discussion regarding using up 50,000 jury selection forms recently printed and making the change when the form is reprinted in approximately six months. The on-line option to make the selection could be made available almost immediately. With no further discussion, a motion was made to add Meals on Wheels to the form at the next printing as a possible choice for donating a juror's stipend. (Time: 1:54 p.m.)

6. Al-39601 Presentation of Teen Court monthly/quarterly statistics, Budget.

Julie Monge, Teen Court, came forward to present the monthly/quarterly statistics. The biggest case load and most community service hours assigned are from the Frisco Municipal Court with whom the County has an interlocal agreement. The biggest caseload in Frisco is theft under \$50 which is due to the retail area in that city. The most common offense in JP 1 is truancy while the most common offense in JP 3-1 is middle school truancy and speeding. JP 3-2 offenses include a variety of general offenses but the majority are speeding and truancy.

There is a steady volunteer base with most of the kids volunteering four times a month. The total event hours is relatively steady and includes training, competition, teen court and the banquet. Ms. Monge gave a brief update on some of the past teen attorneys. Scholarships awarded to these students since 2012 total \$13,700 and Judge Payton and Judge Baxter have provided internship opportunities. The total number of volunteer hours towards Teen Court since 2011 is 848.

The cases are received from the JP offices and Frisco and Little Elm Municipal Courts. They are all Class C misdemeanors and, since this is a diversion program, state law requires the case to be dismissed upon successful completion. The JPs have determined a range of hours to be served for each type of offense and there is a jury of their peers. Teen attorneys are trained and it resembles a real court process. The student is sworn in and there is a defense and prosecution. The jury decides the verdict which is community service hours or a written essay. Sometimes they qualify for counseling and drug testing. Each defendant takes a survey which is provided by COG (Council of Governments). If they qualify, they are sent for counseling and drug testing at no cost to them. They have 90 days to complete all the requirements that the court gives them. Ms. Monge follows up to make sure they are current on their community service and counseling. It's a positive experience and parents are glad their teens got to experience what court is really like.

Commissioner Webb asked what needs to be done to get this program out to more JP and city courts because the numbers are going down. Ms. Monge said statewide there is a decline in cases due to bills that were passed making it more difficult for school resource officers to issue citations. Ms. Monge also feels if more JPs would come to a teen court session they would be more likely to send cases. Commissioner Fletcher thanked Ms. Monge for her work and feels this program is reducing the number of people who may later end up in our jails. (Time: 2:02 p.m.)

8. <u>AI-38983</u> North Central Texas Council of Governments (NCTCOG) Executive Board monthly update, County Judge.

Judge Self said there were a few items of interest that he wanted to discuss with the Court. The first was regarding approximately \$1 million left over in the Texas Workforce Development Board budget. Fifty percent of the budget goes toward childcare. There are 800 providers and 80 of these are considered top tier providers (Texas Rising Star Providers). It was decided to spend these funds on these 80 providers. While this item passed, Judge Self did not vote for it because he felt the money should be used to raise the level of all of the providers, not just the top 80.

The second item, which was not voted on, is regarding the 911 fees for large urban areas that are being held at the state to balance the budget. Funds for a city 911 entity or small rural districts, however, are not held. There is a bill trying to form a district in our area to get more money back. The Judge has asked Greg Hudson, Legal Counsel, to review the bill.

If the bill passes the legislature, before the district can be formed, every single entity, including this Commissioners' Court, would have to agree. The issue is there is no way to get out until the district is dissolved. The Judge asked Bill Bilyeu, County Administrator, to make this bill a future agenda item after the Court has had a chance to look at it.

The last item is a bill that states that every legislator whose district is touched by the NCTCOG (North Central Texas Council of Governments) would be an ex officio member of the Executive Board and would count toward the quorum. This means there would be 42 members, with only 16 being elected officials, and it would be nearly impossible to get a quorum. This is a dramatic change to the makeup of the Executive Board. (Time: 2:09 p.m.)

Everyone is trying to find a model that works. There are people that believe if both the Dallas and Collin County LMHAs (Local Mental Health Authority) get funded at a level that would make us viable, then the other LMHAs across the state will lose some funding. The rider that we submitted will be addressed in the conference committee. (Time: 2:13 p.m.)
