GENERAL DISCUSSION

5. <u>AI-38983</u> North Central Texas Council of Governments (NCTCOG) Executive Board monthly update, County Judge.

The first item of interest was the approval of subsidies for enforcement on the Tarrant County HOV (High Occupancy Vehicle) tolled lanes. Judge Self had no problem with the approval because the RTC (Regional Transportation Council) subsidizes 50% of certain people who drive on that lane. They subsidize 50% of the cost because there is a financial risk to the RTC. The Judge asked about the enforcement on the HOV lanes on US 75 in Collin County. The explanation given was there is a safety issue for enforcing on HOV lanes. Judge Self agreed safety of enforcing is an issue but so is the safety of the citizens as those are the most dangerous lanes in Collin County. The Judge felt the willingness to subsidize enforcement for a financial risk but not for a safety risk is quite a concern; therefore, he asked Commissioner Williams and Commissioner Webb to readdress this with the RTC.

The second item of interest was the regional population estimates presentation which includes sixteen counties. The regional occupancy rate is currently above 90%, meaning there is a shortage of housing, but housing completions are on the rise. The regional population change is continuing to increase. As of January 1, 2015, the regional population had reached almost 7 million which was 97,000 more than January 1, 2014. Frisco, McKinney, Plano and Allen made the list of top 11 cities with absolute change in 2014-2015. Melissa, Celina and Prosper made top 10 small cities list for percent change in 2014-2015. Frisco, McKinney and Plano also made the top 10 list for absolute change for 2010-2015 which shows they are holding pace with the region. Prosper, Melissa, Lavon and Anna made the top 10 small cities list for percent change for 2010-2015.

The last item of interest was Representative Ron Simmons' bill which allows all of the 49 legislators in the region to be members of the executive board. Language has been added to the bill stating the legislators do not count against the quorum. (Time: 1:35 p.m.)

Bill Bilyeu, County Administrator, came forward to follow up on a news article referring to CMS (Center for Medicare and Medicaid Services) giving notice to the State of Texas regarding the expansion of Medicaid. If Medicaid is not expanded CMS will look at the uncompensated care funding for 2016. Uncompensated care are agreements the County has in place with a few hospitals. They make payments separate from the County for Project Access and PrimaCare. If changes occur the County will take over those payments and then the Court will have to decide if funding which is unmatched will continue. There have also been questions on the long term of the 1115 Waiver. Judge Self said the expansion of Medicaid is expected and the Court needs to prepare to look at it for budget. (Time: 1:36 p.m.)
