The Commissioner asked if this was appropriate for this contract or is there some other way we can get that information.

Clarence Daugherty, Engineering, does not feel it is appropriate for this contract since we are looking to Jacobs Engineering Group for their expertise in the demographics projections and the travel demand modeling. Mr. Daugherty believes the COG (Council of Governments) would be a more appropriate source for determining the impact of good mobility versus not good mobility on the business climate in the County.

Judge Self asked where the funds were coming from. Mr. Daugherty will check into this and inform the Court. With no further discussion, a motion was made to approve the item. (Time: 2:01 p.m.)

1. <u>AI-39819</u> Grant application and resolution for the FY2016 TIDC Competitive Discretionary Grant Program through the Texas Indigent Defense Commission to implement a Managed Assigned Counsel (MAC) Program to expand the Collin County Mental Health Managed Counsel (MHMC) program to juvenile and felony cases, 296th District Court.

Judge John R. Roach, Jr., 296th District Court, came forward to address the Court in order to get the next step in the grant process to the TIDC (Texas Indigent Defense Commission) for approval for a MAC (Managed Assigned Counsel) Program with the district courts in Collin County. Judge Roach said there is a problem with the rising costs of indigent defense and applying for this grant would be the best way to solve it. They are requesting two full-time employees and one part-time employee in addition to the MHMC (Mental Health Managed Counsel) Program to manage indigent defense in the district courts. This is a four-year pilot program.

Currently indigent defense is managed by the judges and there is no consistent policy, procedure or pay schedule which results in lost efficiencies. The judges need to manage their docket and not indigent defense.

In the MHMC Program they were able to reduce the number of days in jail by 86%. If in this new pilot program the number of days in jail was cut 10% across the board, that would save the County \$1 million. If the number were reduced by only 5%, it would still save the County \$500,000 and the program would pay for itself. Judge Roach has no doubt the number can be reduced by at least 5%.

Judge Self asked who this team would work for referencing TIDC's key point that this should be independent from the judiciary. Judge Roach said this position would be independent and not report to the judges, but the judges would still have control. Judge Roach said this would be similar to the Auditor's Office or Juvenile Probation which are independent but are supervised by the district judges. Judge Self said those offices are legally independent whereas the district judges would have complete control over this new office.

Judge Self asked Bill Bilyeu, County Administrator, if there was a study program with four different models for this program. Judge Roach answered saying there is a committee which has met but not reached a consensus as a group. Commissioner Webb who is on the committee said this is premature and he is not supportive at this point. The Auditor's Office is doing a cost analysis of the four models discussed: the current system, a MAC program for juveniles, a public defender office and a contract defender model. During the last committee meeting there was discussion on the six ways that we are appointing counsel which are misdemeanors, felonies, appeals, capital, ad litem and juvenile. There was a brief discussion on how many models there would be.

Judge Self would like to see the study. Judge Roach said, as judges and subject matter experts in the field, we have to think about more than cost. We have real solutions to real problems. This is our program and we would like to move forward. Commissioner Webb said it is the judges' job to dispense justice and the Court's job to control costs. Judge Self said he would not vote for this.

Judge Roach said if we don't apply for this grant today we will have to wait another year while costs continue to go up. Judge Self said this grant commits us to four years and we should not commit to this until we are sure this is the model we want. Commissioner Fletcher asked if the judges discussed a hybrid system to determine where we have the most need. Judge Roach said it has been discussed regarding criminal appeals and the capital program.

Commissioner Williams asked when we could get an answer on the grant application. Judge Roach said the decision would be made in August but funding would not be available until October. The Commissioner said receiving the grant does not require us to accept the grant and suggested making the application for the grant while the committee met and reached a consensus. Judge Self and Commissioner Webb feel reaching a consensus will be more difficult than anticipated. Commissioner Webb said in the next month they should be able to start having meetings to discuss cost versus benefit.

Commissioner Hill said he appreciates the idea of saving the County \$500,000 to \$1 million, but it's an unproven estimate and could cost more. There are more questions than answers and the Commissioner does not want to be driven by the grant. Judge Roach asked to table this item. (Time: 1:57 p.m.)

GENERAL DISCUSSION

5. <u>AI-39847</u> Appeal of Historical Tax Exemption for property located at 214 E. Louisiana Street, McKinney, Texas, Commissioner, Precinct 3.

Commissioner Hill introduced Cleo Meredith, a business owner in McKinney, who has asked for the Court's consideration of a historical tax exemption on her property. The exemption was applied for on the property and was denied first by the Historical Commission and then the Commissioners' Court approved the recommendation by the Historical Commission.

Ms. Meredith came forward and explained they are in the process of repairing and renovating the building. It is a large project and there have been difficulties repairing the foundation. Ms. Meredith briefly explained the issues with the foundation and presented an engineering report and appraisal to the Court. The City of McKinney granted TIRZ (Tax Increment Reinvestment Zone) financing and the funding is now available for the foundation repair. She is asking the Court for the tax exemption in order to put more money into the repair.

Commissioner Hill asked Janice Klein, Collin County Historical Commission's Tax Abatement Chairman, to come forward. Ms. Klein explained the ordinance was amended last year to allow properties throughout the County that did not have national or state historical landmark designation to be able to write up a history of their property and join our historic asset survey interactive map. The Historic Commission was able to give the Meredith's the tax abatement last year even though the exterior of the building was questionable. Properties must be in good condition to qualify for the tax abatement. This year the property was inspected in February and there were cracks and peeling paint which are among the few things they as volunteers are looking for to determine whether to approve or deny the abatement. The requirements are straightforward.

Ms. Klein said if the Merediths are granted the abatement this year, then to be fair the Commission would have to go back and give at least one other property the abatement because it also had exterior issues.

Commissioner Fletcher thanked Ms. Klein and her committee for volunteering their time to serve on the committee and inspect the properties. The Commissioner is not in favor of granting the abatement especially since there has already been a grace period in the past. If the property is brought up to the required standards, the Commissioner would have no problem with granting the abatement.

Commissioner Hill appreciates the Merediths' willingness to bring their property up to the standards, but approving this appeal would open us up to at least one other application and a change in our policy. The Commissioner looks forward to supporting their application next year. With no further discussion, no motion was made to approve the item. (Time: 2:18 p.m.)
