#### **GENERAL DISCUSSION**

5. Al-33858 RTC monthly update, Commissioner, Precinct 4.

Commissioner Webb updated the Court on the last RTC (Regional Transportation Council) meeting. The most interesting item was planning related to Mobility 2040. Plan development will occur between now and October with a recommendation in December 2015. The RTC is expected to take action in March 2016. The 2017-2020 Transportation Improvement Program (TIP), which is a short-term plan, is also in the development stage. Data and projects will be developed through the end of the year. A list of TIP projects will come out in January 2016 with a final list in April 2016. The final TIP list will be approved in October 2016.

Another item of interest was the new TIGER (Transportation Investment Generating Economic Recovery) 2015 Discretionary Grant Program announced by the United States Department of Transportation. The RTC is recommending three projects for TIGER 2015. Those projects include I-35W for a little under \$20 million, the Park Lane project for \$10 million and regional connectivity through technology for \$10 million.

Commissioner Webb also stated he was appointed to the RTC's nomination committee. (Time: 1:33 p.m.)
