On Monday, June 8, 2015, the Commissioners' Court of Collin County, Texas, met in Special Session in the East Hallway, 1st Floor, of the Collin County Courthouse, 2100 Bloomdale Road, City of McKinney, Texas, with the following members present, and participating, to wit:

1. Judge Self called to order the Special Session meeting of the Collin County Commissioners' Court at 11:00 a.m.

2. Public Comments:

Ceremony to honor Collin County fallen warriors.

Judge Self thanked everyone in attendance for helping honor these fallen warriors. Judge Self introduced McKinney artist Colin Kimball, a United States Air Force Veteran and creator of the portraits.

Mr. Kimball read a short biography of each of the Fallen Warriors:

Aenard "Ann" Compton

Sgt. Robert W. Bently

LCPL Steven W. Hutchings

LCPL Jacob D. Hayes

Mr. Kimball said the importance of the portraits is not to show what he has done as an artist; it is to tell the stories of these fallen warriors so that those stories can be carried forward. Mr. Kimball hopes people who frequent the halls of the courthouse will take note of the fallen warriors and be inspired so they themselves can have a second chance. (Time: 11:13 a.m.)

Stacey Kemp, County Clerk, came forward to present Mr. Kimball with a donation of \$1,000.00 on behalf of the County Clerk's Charity Fund to continue his work with the Collin County Fallen Warrior Portrait Project. Mr. Kimball thanked Ms. Kemp and stated the check will be donated to the Bill Bryan Post 110 American Legion who funds the entire effort. (Time: 11:14 a.m.)

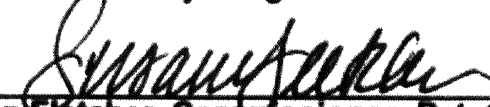
The Court did not recess into Executive Session. There being no further business of the Court, Judge Self adjourned the meeting at 11:14 a.m.

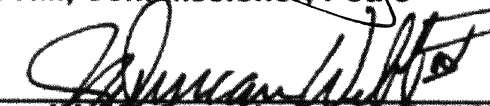
