On Monday, August 10, 2015, the Commissioners' Court of Collin County, Texas, met in Regular Session in the Commissioners' Courtroom, Jack Hatchell Collin County Administration Building, 4th Floor, 2300 Bloomdale Road, City of McKinney, Texas, with the following members present, and participating, to wit:

Commissioner Webb led the Invocation.

Judge Self led the Pledge of Allegiance.

Commissioner Fletcher led the Pledge of Allegiance to the Texas Flag.

1. Judge Self called to order the meeting of the **Collin County Commissioners' Court** at 1:30 p.m. and adjourned the meeting at 2:11 p.m.

President Self called to order the meeting of the <u>Collin County Health Care</u> <u>Foundation</u> at 2:11 p.m. and adjourned the meeting at 2:11 p.m.

President Self called to order the meeting of the <u>Collin County Housing Finance</u> Corporation at 2:11 p.m. and adjourned the meeting at 2:11 p.m.

2. Public Comments.

Mike Rumfield, President of the Collin County Deputies Association, came forward to address the Court on numbers that were mentioned at the last court. The number of applicants to Collin County job openings was said to be 200 applicants for 20 job openings which represents a 10 to 1 ratio. McKinney recently had a test and had more than 270 applications for four positions which represents a 70 to 1 ratio. While 10 to 1 is good, 70 to 1 is better.

The Deputies Association for years has said that certain aspects of the policy could hinder their ability to retain and recruit quality individuals in the future. Mr. Rumfield stated numbers recently put out by Judge Self on the turnover ratio supported this. These numbers show there has been an increase of almost 30 percent in turnovers in the past four years. According to the County's policy as it relates to compensation, recruiting and retention, those numbers should have been stagnant and not increased. Mr. Rumfield expressed his appreciation for the Judge's support for the argument the Deputies Association has had for the past four years.

Mr. Rumfield then read the following quote from *SHEEPDOG: Meet our Nation's Warriors*, a children's book co-authored by LTC David Grossman. "Their job is dangerous and most days thankless. But still the sheepdogs go out each day and do their job to the utmost of their ability armed with love. They do this because they know if no one did it, our civilization could not exist."

This is a simple and profound concept and states without a strong public safety and military, our civilization here could not exist. If this is worthy enough to be taught to children, it's worthy enough for this Court to honor and make sure that our civilization, standard of living and the ability to continue to recruit corporations to help this county improve and grow remains intact. We will only be able to do that if we have sound county public safety individuals supporting our sound municipal public safety individuals to keep the crime rate low, cases prosecuted and to keep people feeling safe. The Judge asked the Court to watch to make sure these funds are being spread across these organizations and to encourage those who have not applied for grants to apply. Commissioner Williams agreed that all of the entities should be encouraged to find something that would meet the criteria.

Commissioner Webb wanted the items pulled because in Article IV of each of the Agreements it states, "The County enters into this Agreement with the Guild for the purposes enumerated in Article I." This reference is incorrect and should refer to "Article II." A motion was made to approve the item with the change made to each of the Agreements. (Time: 1:36 p.m.)

GENERAL DISCUSSION

5. <u>AI-40250</u> Grant application for the FY 2016 General Assistance Grants Series 16-A through the Texas Veterans Commission in the amount of \$100,000 to expand the Veterans' Court into the North Texas Regional Veterans' Court and provide for a full-time Program Manager/Supervision Officer including office furniture, equipment and supplies, 296th District Court.

Judge John Roach Jr., 296th District Court and presiding Judge of the Collin County Veterans' Court, came forward to ask the Court to join the North Texas Regional Veterans' Court. The Texas legislature has allowed counties, through statutes, to create a Regional Veteran's Court and Rockwall County has already passed a resolution to join. The counties joining together would provide the best outreach for veterans. Some of the other counties that have expressed interest in joining are Hopkins, Grayson, Hunt and Kaufman. The resources are not yet available to move this forward. If Collin County joins the Regional Veterans' Court, we would like to ask the Texas Veterans' Commission to fund a grant for a program director/probation officer who can help us reach out to those counties and set policies. If we can come together as a Regional Veterans' Court and combine resources and efforts, that will give us the ability to help as many veterans as possible who are eligible for this type of program.

Judge Self asked why Collin County is hosting this grant and if the participating counties would provide funding. Judge Roach said this is not a matching grant. Collin County would be hosting the program director in CSCD (Community Supervision and Corrections Department) since Judge Roach will be the presiding judge over the Regional Veterans' Court. The grant would pay for all of the equipment and computers. A Veterans' Court by statute can be funded using filing fees. As we bring on other counties, they will be asked to implement filing fees which can go towards the program director.

Judge Self asked how much time Judge Roach spends on this. Currently Judge Roach spends one and half hours per month in Rockwall. As other counties are brought in, he plans to utilize video conferencing and the program director will be critical in creating the programs and appearing either in person or through video conferencing. Currently, there are nine people in the Veterans' Program in Collin County and nine in Rockwall County.

There was a brief discussion regarding how the finances will be handled if other counties join. Commissioner Webb asked if the counties will share the cost of the program director. Judge Roach does not have an answer for this yet. Jeff May, Auditor, said there would be a separate fund to account for the Veterans' Court and it would have a receivable for those other counties. Commissioner Williams said it would require an ILA (Interlocal Agreement). Commissioner Webb asked if after the first year the participating counties would share in the cost of the program director position. Judge Roach said the deal would have to include all counties having "skin in the game."

Judge Roach said the director would be either a contract employee or, since the position would be monitored by CSCD, a CSCD employee. The Court's concern is that it does not control CSCD employees and, therefore, would not be able to cut off the position if it felt the need to do so. Commissioner Fletcher asked at what point Judge Roach would ask for additional help so as not to take away from his responsibilities with Collin County. The Judge explained that Mary Murphy, the presiding judge for the administrative region, mentioned that she might consider appointing a judge to handle just the Veterans' Court.

Judge Roach said this is the last Commissioners' Court in which to meet the TVC (Texas Veterans' Court) deadline for applying for the grant. Commissioner Williams asked if there would be enough time, if it were approved today, to work out the details about where this employee would end up. Judge Roach said there would be enough time and they could probably do a grant amendment as to who the employee falls under. There was a brief conversation regarding the other counties interest in this.

Commissioner Hill asked if we succeed in signing up all the counties, why can't they stand alone. Judge Roach said he has a probation officer, defense lawyer, a representative from the jail, and the Veterans' Justice Outreach Coordinator and that is a large group of people that have to get together. The smaller counties may not be able to justify all those resources for one or two veterans. The Commissioner does see the advantages of shared resources instead of each county recreating the program if they don't have the numbers with the stipulation that each county is covering their share of the resources they are using. Judge Roach said they are also anticipating starting a 501(c)(3) through the mentors that could be another funding mechanism which doesn't come from taxpayer money.

While Commissioner Webb understands the efficiency side of this, without the other counties supporting the system, including the time associated with our judge and our staff, he is not sure he wants to take this on. The CSCD employee issue is also a big concern. Once this is approved, it is out of the Court's control and the Commissioner has no desire to do that. If the Commissioner knew the other counties would step up on funding and the CSCD issue was resolved, he would be supportive of this.

Judge Roach said the other counties would replicate our team and explained that Collin County will monitor only Collin County. The program director is the only crossover from county to county. Commissioner Williams moved to allow Judge Roach to submit the grant and to have further discussions before a final decision is made. Judge Self likes the idea of this and said these people have been in harm's way and the crime must be directly related to their combat injury, but there must be equity from the other counties. With no further discussion, a motion was made to approve the item. (Time: 2:00 p.m.)

Judge Roach said even if we did not receive the grant, he would preside over Collin and Rockwall counties. We would be able to share our mentor program, our services and employers from both counties. Judge Roach would then limit it to a two-court deal. Judge Self said the Court wants answers to item 5 before they commit to item 6, and the Court would accept the grant and approve participation at the same time. (Time: 2:01 p.m.)

7. <u>AI-40259</u> Fleet Presentation, Public Works.

Jon Kleinheksel, Public Works, presented a PowerPoint presentation on the State of the Fleet. The presentation was based on FY2014 and does not include new acquisitions. There are 415 over-the-road vehicles, 274 grounds equipment units and 207 off-road units for a total fleet of 896. There are also 22 generators that are serviced annually. Mr. Kleinheksel showed a life expectancy chart for all the equipment and then explained the replacement criteria. Equipment is evaluated on four criteria: age, mileage/hours, maintenance/repair cost and condition. For the over-the-road fleet age, the eight-year-old average will drop to 7.43 with the FY2015 acquisitions. The off-road fleet age will drop from 9.5 to 9.4 years. Fuel usage has decreased from FY2014 to FY2015. Total miles driven are 3,876,304 with a fleet average of 9,454 annual miles per vehicle. Mr. Kleinheksel then explained the fleet maintenance costs by unit type. There were 6,180 work orders with 882 work orders per technician per year. There was a brief discussion regarding the maintenance costs on the motorcycles. (Time: 2:11 p.m.)
