On Monday, November 9, 2015, the Commissioners' Court of Collin County, Texas, met in Special Session in the East Hallway, 1st Floor, of the Collin County Courthouse, 2100 Bloomdale Road, City of McKinney, Texas, with the following members present, and participating, to wit:

Chaplain Wesley Geary led the Invocation.

Commissioner Hill led the Pledge of Allegiance.

Commissioner Fletcher led the Pledge of Allegiance to the Texas Flag.

**1.** Judge Self called to order the Special Session meeting of the **Collin County Commissioners' Court** at 11:30 a.m.

#### 2. Public Comments:

Ceremony to honor Collin County fallen warriors.

Judge Self introduced McKinney artist Colin Kimball, a United States Air Force Veteran, who donates his time and talent to the Fallen Warrior project. Mr. Kimball gave a short biography of each of the Fallen Warriors and explained the symbolism in the background of the portraits.

There was a rededication of 1<sup>st</sup> Lt. Russell A. Steindam's portrait. Lt. Steindam received the Congressional Medal of Honor posthumously. There have been approximately 3,500 recipients of the Medal of Honor since the Civil War, and Mr. Kimball requested the Court consider renaming the Collin County Courthouse the Russell A. Steindam Courthouse as a living reminder that Collin County proudly stands for the service of all Americans and the fallen heroes of even the unpopular wars. (Time: 11:54 p.m.)

Stacey Kemp, County Clerk, came forward to present Mr. Kimball with a donation of \$1,750 on behalf of the Offices of the County Clerk and County Court at Law Clerk to continue his work with the Collin County Fallen Warrior Portrait Project. Mr. Kimball thanked Ms. Kemp for the donation. (Time: 11:56 a.m.)
