Patricia Seals, Deputy Elections Administrator, presented Court members with copies of the Election Summary Reports for the Constitutional Amendment Election held on November 3, 2015. Ms. Seals was present to canvass the results of the Constitutional Amendment Election. She read the combined accumulated totals for Early Voting and Election Day as follows:

Constitutional Amendment Proposition 1: For 48,870; Against 4,174.

Constitutional Amendment Proposition 2: For 49,730; Against 2,887.

Constitutional Amendment Proposition 3: For 37,372; Against 14,692.

Constitutional Amendment Proposition 4: For 35,667; Against 16,365.

Constitutional Amendment Proposition 5: For 45,068; Against 6,893.

Constitutional Amendment Proposition 6: For 43,035; Against 9,294.

Constitutional Amendment Proposition 7: For 46,014; Against 6,562.




There being no further business of the Court, Judge Self adjourned the meeting at 8:32 a.m.


