Commissioner Webb pulled this audit report which was for the 3rd and 4th quarters of FY2013. There were three items written up on this report. The first issue is related to security at the Plano location. Jeff May, Auditor, said badge readers were installed on the doors and the issue has been resolved.

The second item, which is still going on, involves monies being generated through an office with no accounting of those monies. People are giving their old license plates to the Tax Assessor Office who is then recycling the plates and receiving money. The Commissioner has an issue with this and the fact that there is no signage letting the public know what is being done with the license plates. Commissioner Webb asked Mr. May if the Court has the power to dictate whether or not disposal points that generate money can be set up and used for other things. Mr. May said, while he wrote this up because of the accounting issue, he has not found a law regarding this. Since the monies are being used for the benefit of the employees, Mr. May feels there needs to be an accounting of it. If a department collects funds and there is no law saying these funds go to this department, then the funds would go to the General Fund. There was a lengthy conversation regarding the legality of this issue and the fact that there is no signage stating what the money is being used for. The Court would like an accounting of the money.

The third item is regarding the Tax Assessor's Office in Plano which hires Plano Police Officers for security and has to pay the officers at the end of each day. Since it would take weeks for the checks to be issued, the Assessor created a fund using his personal funds to pay the officers who in turn sign limited powers of attorney designating someone in the Assessor's Office to endorse the checks which are then cashed. This process has since been modified and the Assessor is accounting for the funds with a log showing who received cash. Commissioner Webb suggested the Court authorize a petty cash fund to pay the officers and then 1099 the officers based on the amount of cash received over the year. This eliminates the need for the powers of attorney. Mr. May will look into the Commissioner's suggestion. Commissioner Fletcher suggested the Auditor speak with someone at TAC (Texas Association of Counties) regarding the legal questions. Commissioner Williams would like the item to remain on the Outstanding Items list. With no further discussion, a motion was made to accept the Auditor's findings. (Time: 2:07 p.m.)

GENERAL DISCUSSION

5. <u>AI-40888</u> Procedures for plat revision for the replat of Lavon Hills Lots 81B1 and 81B2 per Local Government Code 232.041, Engineering.

Clarence Daugherty, Engineering, said he is not asking for Court approval on this but rather for guidance on handling public notifications. If the revision or re-plat is not of public interest, neighbors within 200 feet are notified and it is put on the website. If it is of public interest, a notice is placed in a newspaper and certified letters are sent to all owners in the subdivision. Actions that cause more demands on a school, park or roadway would be of public interest. Commissioner Williams said approving a plat is a ministerial action and, if it meets the requirements of the subdivision ordinance, the Court has no option other than to approve it. Mr. Daugherty wants to clarify how to handle the notifications. A lengthy conversation regarding notifications ensued. Mr. Daugherty will move forward with this item and then engage an attorney to look at it in a more general scale. (Time: 2:31 p.m.)

6. <u>AI-40930</u> Budget amendment in the amount of \$3,966,834 to correct negative cash and replenish fund balance to \$2,000,000 for the Employee Health Insurance Fund, Auditor.

Jeff May, Auditor, said claims are paid once a week and last week a claim came through for \$730,000 which is twice the average claim amount. The fund balance went negative in November. Mr. May proposed transferring \$2.9 million into the insurance fund. These funds will come from all of the departments' payroll funds and will require a budget amendment. There was also \$1 million taken from the County Insurance Fund and \$600,000 from the Workers' Comp Insurance Fund. Both of these have had excess fund balances over the prior years.

Monika Arris, Budget, said the amount taken from each department was allocated based on the number of employees in that department so it is proportional. Every payroll department was impacted by this. It needed to be done this way for the CAFR (Comprehensive Annual Financial Report) report. Commissioner Webb asked how much is expected to come back in and will it go into the Insurance Fund from the stop loss payments. Cynthia Jacobson, Human Resources, said they are expecting approximately \$1.6 million back and \$300,000 has already come through. This money will go into the Insurance Fund.

Commissioner Webb said the Auditor should have informed the Court of this during budget and would like it monitored better. Mr. May said that will be done from here on out. This does not touch the FY2016 budget and is only cleaning up for CAFR. With no further comments, a motion was made to approve the Auditor's recommendations to shore up the Health Insurance Fund. Commissioner Hill said, when he took over as Chairman of TAPS (Texoma Area Paratransit System), his goal was to cut expenses as quickly as possible and increase reimbursements coming to the agency from the funding partners. At the last meeting he stepped down as Chairman and off the board completely, and made it known that he would recommend Commissioners' Court move in a new direction for a rural transit provider. The reason for this was the Commissioner learned the TAPS staff had not cut expenses as he had asked, and was still not making payroll or paying their bills. Furthermore, debt went up since September by half a million dollars. On the reimbursement side, we were having trouble with funding partners because they too realized the agency had failed. TxDOT (Texas Department of Transportation) sent a letter to TAPS saying that they may be requesting repayment of \$1.7 million because the agency had not kept proper records for reimbursement. In some cases they hadn't even spent the money they were trying to get reimbursed for.

Commissioner Hill recommends that the Court pull back its designation of TAPS as the rural transit district and formally appeal to TxDot and NCTCOG (North Central Texas Council of Governments) for their consultation and advice. They have indicated they will be happy to help the County as we look for solutions and have asked for a formal resolution giving them the opportunity to do so.

Commissioner Webb said there was an action item on the RTC (Regional Transportation Council) agenda to approve contingency emergency supplement transit options for TAPS service for people within Collin County cities excluding McKinney; the McKinney Urban areas; the rural areas of Collin County; and the rural areas of Wise County. It was a lengthy and intense discussion with many questions and answers. The \$700,000 contingency emergency supplement was approved by a vote of 43–1. Commissioner Webb was the one vote against it because he was not happy with the concept of how they wanted to allocate the funds. It is the Commissioner's understanding that STAR Transit out of Rockwall and DART (Dallas Area Rapid Transit) are in the process of submitting proposals to provide these services. DCTA (Denton County Transportation Authority) will provide services in Frisco.

Commissioner Hill said Jessie Huddleston, NCTCOG, wanted to know if it's the Court's intention to be done with transit or are we still looking for solutions for our community. Her advice was to make it known that we are asking for assistance and are moving forward. Commissioner Webb said the south Collin County metro area as well as the McKinney urban area is a COG responsibility - not the County's responsibility and the funding comes from TxDOT. The City of McKinney is doing an analysis and Commissioner Webb suggested finding out where they are heading and possibly piggy backing off of them. Judge Self said it is the Court's responsibility to designate the rural provider but it would be wise to let the cities decide. Commissioner Hill said in our rural district TxDOT is the primary funding agency.

Cynthia Zinn, DaVita Dialysis in McKinney, came forward with a public comment. Ms. Zinn wanted to express the impact the public transportation system shutdown has had on dialysis patients and to request the Court's urgent assistance. Patients require these life-saving dialysis treatments every other day. There are 15 patients at her clinic alone that require public transportation to receive these treatments. Of these patients ten are senior citizens, three are blind and one is in a wheelchair. These are some of the most vulnerable people in our population. They are now paying \$400 per month for a taxi compared to the \$40 per month previously for public transportation. Ms. Zinn described some of the hardships experienced by these patients since the shutdown.

Judge Self said the \$700,000 approved by the RTC will be for these types of people who need it the most. Commissioner Webb will let Ms. Zinn know who to contact in order to get transportation for these patients. With no further discussion, a motion was made to withdraw the Commissioners' Court designation of TAPS as the Collin County rural transit district, and requests partnership and assistance from TxDOT and NCTCOG for continuing rural transit services in Collin County pursuant to state law. (Time: 3:13 p.m.)

Commissioner Webb said we approved the continuation of the General Electric Test Track Funding Proposal. This is a railroad test track and up to \$3 million in funding will be provided by Denton County and the City of Fort Worth.

Next the federal government approved a new five-year transportation funding bill that provides a 5% increase in funding from the current funds from the first year. This increases transit funding the first year by 8%. Also approved was a second and final installment of the MPO (Metropolitan Planning Organization) Revolver Fund with the city of Dallas and Dallas County.

Lastly, Mobility 2040 was approved to go public. Meetings will start in December and it will be an action item in March 2016. The Commissioner was able to add corridor studies of US380, SH78 and FM1378. Judge Self said the Dallas metroplex has already started pushing to get the entire 5% increase in funding. Commissioner Webb said this plan is amended every two years and he hopes Collin County has more lines on the map in order to start pushing for more funding. (Time: 3:18 p.m.)
