# **GENERAL DISCUSSION**

**5.** <u>Al-40925</u> Public Hearing – Placement of regulatory signs on various County Roads, Public Works.

Judge Self opened the public hearing for placement of regulatory signs on various County Roads and asked for public comments at 1:41 p.m. Hearing no comments, the hearing was closed at 1:41 p.m.

Commissioner Hill referred to the regulatory signs for Baker Road and asked why it is necessary to post a speed limit now when there have been no speed related accidents or issues on this road. Jon Kleinheksel, Public Works, stated when the County makes upgrades to a road the County is mandated to put in a speed limit. A radar speed study is done on each road. When all the data is gathered the County uses an 85<sup>th</sup> percentile of what the radar speed study showed to determine the proper speed limit. There is a 5 mph variance to go up or down given the circumstances with the road. For this particular road the recommended speed limit is 40 mph. Commissioner Hill asked why the recommended speed for Bourland Bend is 45 mph when the 85<sup>th</sup> percentile suggests 52 mph. Mr. Kleinheksel said it was due to the variables along the road. Those variables included sharp turns, hidden driveways and hills.

Commissioner Hill stated most complaints received from his constituents related to this item are that the speed limits are lower than what safe driving would allow. The Commissioner does not want to fix these limits and later hear the limits should be higher. He suggested holding this item in order to review the list with Mr. Kleinheksel and to inform his constituents of the study and public hearing. Mr. Kleinheksel said if the item is pulled another notice will need to be put in the paper notifying the public of the hearing which will push the Court's approval by 30 days. With no further discussion, the item was held. (Time: 1:51 p.m.)

#### 6. Al-41010 Rural Transit District, Commissioners Court.

Following the Court's action for a resolution to reach out to TxDOT (Texas Department of Transportation) and the NCTCOG (North Central Texas Council of Governments) Commissioner Hill contacted the entities to ask for their guidance. Both entities stated they would be unable to be present at this Court meeting. Presently there have been letters of recommendations received from them. The Commissioner would like to keep this item on future agendas while working with TxDOT and the NCTCOG.

Judge Self said the NCTCOG Executive Board approved \$675,000 in transit funds for supplemental transit options for Collin and Wise Counties. He also said the County should let the cities which will have funds in the game to take the lead. Commissioner Hill stated if McKinney comes forward with a provider found to be a suitable solution he would like the Court to entertain the idea of partnering with the City. Judge Self said there is a timetable of 90-120 days for decisions to be made.

McKinney sent letters out today to six or seven organizations to give input. Commissioner Webb agreed the Court needs to see what McKinney decides to do. Commissioner Hill added, TxDOT and NCTCOG have reached out to TAPS (Texoma Area Paratransit System) to get the 20 vehicles paid for by Collin County funding separated from TAPS in order to have those vehicles transferred to whomever the County uses as a vendor. # 7. Al-40958 Handgun restrictions on county property, County Judge.

Bill Bilyeu, County Administrator, said Facilities is in the process of installing new signage. After speaking with the attorney it was decided to add signage to the 900 Buildings in Plano which house the Adult and Juvenile Probation departments because those have been interpreted to be court offices. Foldable signs will be installed at Myers Park to use during school events which are covered under the statute. A portable sign will be made to use at offsite Commissioners' Court public meetings. There is AG (Attorney General) discussion regarding multiuse buildings like the Administration Building which house a courtroom, Commissioners' Court, and other official offices on whether the whole building is prohibited or just the JP (Justice of the Peace) area. If the AG rules the JP area is the only area prohibited then signage will be placed just on those offices and courtroom. As for the courthouse, two postings are required: one prohibiting concealed handgun/weapons and one prohibiting open carry. Mr. Bilveu said this item is separate from employees which is a personnel manual issue. Currently anyone who is not a law enforcement officer is prohibited under the personnel manual. In regards to private non-public areas the elected official or department head has discretion. For example, if a person is taken into an interrogation room from the lobby of the investigation side of the Sheriff's Office internal procedures can require the person to check in their weapon or take it back to their vehicle.

Mr. Bilyeu will return to Court following the AG's guidance on signage. If there are any changes signs will taken down or installed accordingly. Commissioner Hill stated if the AG indicates leeway with multiuse buildings he would prefer signs not posted on the entire Administration Building. (Time: 2:04 p.m.)

**9.** <u>AI-38983</u> North Central Texas Council of Governments (NCTCOG) Executive Board monthly update, County Judge.

Judge Self said the \$800,000 request to pay for the document management system over the next five years was passed. However, he has asked Caren Skipworth, CIO, to work with the NCTCOG (North Central Texas Council of Governments) to get that number down. A request of \$75,000 in local funds from the Regional Transportation Council to be matched with \$225,000 in federal funds to promote pedestrian and bicycle safety education within the region was approved. The Judge voted against this program as it is a "feel good" program distributing pamphlets and brochures. A resolution was approved authorizing the agreement to partner with the University of Texas at Arlington to develop an aviation gamification application. Because there are so many aviation jobs happening in this region the NCTCOG believes there is a need to encourage young people to go into aviation. Judge Self voted against the resolution because he does not believe this is a function of the NCTCOG. As mentioned previously, transit money was approved for the region for the TAPS (Texoma Area Paratransit System).

The Judge voted for a resolution authorizing a contract of \$637,000 with HALFF Associates, Inc. for the FEMA's (Federal Emergency Management Agency) Cooperative Technical Partners program which was approved. It was discovered that the National Resources Conservation Service and the Texas Commission on Environmental Quality issue with dams is separate from FEMA and the NCTCOG. They are similar programs but do not crossover. (Time: 2:08 p.m.)
