GENERAL DISCUSSION

5. Al-40996 Indemnification of Constable Precinct 4, Auditor.

Jeff May, Auditor, explained in August there was an accident with a constable vehicle. According to the policy, this needs to be brought to Commissioners' Court to indemnify the elected official because the piece of equipment is valued over \$20,000. Mr. May's responsibility is to make sure there was no negligence or criminal activity on the part of the elected official. Mr. May found nothing to indicate negligence or criminal activity on the part of Constable Joe Wright, Precinct 4. Therefore, Mr. May's recommendation is to replace the vehicle.

The accident occurred on Community Avenue in McKinney. The vehicle went off the road and struck a light pole which totaled the vehicle. The driver did have driving training in 2014, and there was no determination as to what caused the driver to veer off the road. The vehicle left the road 100 feet before it struck the pole, and there were no evasive maneuvers made or skid marks from braking. Mr. May said Constable Wright also investigated the scene as well as DPS (Department of Public Safety). Judge Self said something caused the accident and there are three possibilities. They are: 1) the driver had a medical condition; 2) the driver was doing something that distracted him; or 3) the vehicle, which was only one day old, could have malfunctioned. The Judge asked if forensics were done on the driver's medical condition and the vehicle. Mr. May said the driver was cleared by two doctors which ruled out a medical condition. The driver's phone log was reviewed and he was not on the phone or texting at that time. Jon Kleinheksel, Public Works, said the black box from the vehicle was not pulled because GPS showed the vehicle was traveling at the proper rate of speed and it would not have given any indication as to the cause of the accident. Cynthia Jacobson, Human Resources, said pulling the black box would cost \$1,000. The black box would show speed, braking and maneuvering. There was a witness who stated there were no evasive maneuvers made.

Commissioner Fletcher stated these questions could be answered if there were cameras in the car. There was a brief discussion regarding the DPS investigation. Judge Self asked Bill Bilyeu, County Administrator, for a future agenda item to explore using an independent agency for these types of investigations so there is no conflict of interest. With no further discussion a motion was made to approve the item. (Time: 1:55 p.m.)

7. Al-41045 Update on the December 26, 2015 storm activities, Commissioners Court.

Judge Self updated the Court on the recent tornados that tore through Collin County damaging homes and businesses. The Judge feels the County will meet the threshold for assistance. The Texas Department of Emergency Management completed their inspection last Friday. A disaster resource center was activated at the First Baptist Church of Farmersville and the volunteer sign-up center was held at the Best Community Center. There were over 500 volunteers registered and hundreds more than that actually volunteered. There were approximately ten volunteer organizations and RPMx Construction Company volunteered to take all of the debris to the landfill. Judge Self agreed under Emergency Management to pay RPMx's tipping fees at the Melissa landfill. RPMx donated hundreds of thousands of dollars in manpower and major equipment. There were three fatalities in Collin County – two in Copeville and one in Blue Ridge.

Jason Lane, Homeland Security, said there were 127 residences and 13 businesses affected. Of those, 56 suffered major damage or total destruction, 35 had moderate damage and 49 had minor damage. They are still in the process of identifying those who had insurance since that will factor into the Disaster Declaration for individual assistance. A tour of the damage was conducted with the State, FEMA (Federal Emergency Management Agency) and the SBA (Small Business Administration). Mr. Lane is optimistic that FEMA would declare this for individual assistance.

The FEMA Disaster Declaration includes both public and individual assistance. Individual assistance would provide assistance directly to those affected by the storms. On the public assistance side, the County would get reimbursed for the expenses it incurs. The threshold for public assistance is \$2.85 million and Mr. Lane feels confident that will be met. Agricultural assistance involves a Disaster Declaration with the USDA (U.S. Department of Agriculture). There is a local committee in the County based out of the Farm Services Agency which assesses the reports on agricultural damage. Mr. Lane does not believe there was enough agricultural damage to meet the threshold. For businesses affected by the storms, the SBA primarily provides low interest loans. Mr. Lane recommended directing those in need of individual assistance to his office stating what their needs are. Those in need of agricultural assistance should contact the County Extension Agent or the USDA. Businesses should also contact Mr. Lane's office for guidance.

Commissioner Fletcher would like to better communicate the County's role in emergencies. Most citizens don't realize that the County cannot take its equipment onto private property. The Commissioner suggested looking at the legislative agenda and possibly opening up these limitations during a disaster declaration. The Commissioner would also like to receive real-time texts sent to the Court, law enforcement and Public Works during these times.

Mr. Lane showed a map of the storm tracks and said GIS (Geographic Information Systems) is working with the Central Appraisal District on the post tornado aerial view. Judge Self said the Chief Appraiser is appraising the damaged properties.

Mr. Lane briefly explained VOAD (Voluntary Organizations Active in Disaster) is a group of volunteer organizations that coordinates the teams for disaster recovery. Commissioner Fletcher wanted to publicly thank the Collin County Association of Realtors and especially Matt Hilton for their work in responding to the disaster. Commissioner Williams would like Commissioners impacted by a disaster to be given notice of the VOAD meetings. There was a lengthy discussion regarding staff notifying the entire Court about what is going on during an emergency in the future. (Time: 2:33 p.m.)
