#### 2. Public Comments.

Carroll Maxwell, McKinney, came forward to address the lack of adequate transportation for the indigent population in Collin County. Collin County is blessed with an abundance of church organizations many of which have come together to provide services such as the Food Pantry and Seniors Helping Seniors. In the past people turned to faith-based organizations to fulfill community needs, and Mr. Maxwell would like to see the Court work with these organizations to help solve the problem of indigent transportation. Instead of scheduled bus routes, the service could resemble Uber for the indigent. (Time: 1:41 p.m.)

Roy Serpa, Fairview, came forward to comment on an email from Judge Self stating a number of misperceptions among county employees regarding the status of the employee program. Mr. Serpa said the County has a good program for compensating and developing employees but employees are not well aware of it. Eric Nishimoto, Public Information Officer, came forward to update the Court on the local activities planned for the Collin McKinney Sestercentennial. Most residents of Collin County know very little about this legendary hero. The McKinney Chamber's annual banquet will feature Collin McKinney and a corporate donor, John Rattan, will donate funds for a giveaway. The giveaway will be approximately 400 copies of a new book about Collin McKinney. Mr. Nishimoto authored and illustrated the book. The Chamber also asked for a short video on Collin McKinney to be used throughout the year.

The Historical Commission, Collin College and many local communities are also planning events to raise awareness of what a remarkable man Collin McKinney was. The celebration will kick off on April 16<sup>th</sup> in McKinney Square with exhibits, activities and a birthday cake decorating contest among the vendors in the square. The goal is to continue the sestercentennial into next year.

The reconstruction of the McKinney homestead and the excavation of the McKinney farmstead have been big projects. There have also been discussions about erecting a statue in honor of Collin McKinney. Mr. Nishimoto asked the Court to help raise awareness in their communities and to contact him if other cities want to have their own celebrations. (Time: 2:02 p.m.)

# 9. <u>AI-41059</u> Rural Transit Services, Commissioners Court.

Tracy Homfeld, Engineering, came forward with answers to the Court's questions regarding rural transit in Collin County. The first question was regarding the immediate need for a taxi cab voucher program. NCTCOG (North Central Texas Council of Governments) said this funding is a loan from the RTC (Regional Transportation Council) and must be paid back. The Court had asked if this is something that TxDOT (Texas Department of Transportation) would be able to repay. The answer is no because there would need to be an active grant agreement between the County and TxDOT during the time the expenses were incurred.

The second question is whether or not it is the responsibility of the County to identify the transit provider. The County must first take the steps outlined in Chapter 458 of the Transportation Code to form itself as the designated Rural Transit District for Collin County. After doing this the County can choose to provide the service itself by setting up its own transit operations, or it can choose to contract out to one or more providers for those services.

The third question was can more than one provider be appointed to cover the rural areas. The Rural Transit District can identify as many providers as it deems necessary to provide service in Collin County. This decision needs to follow all necessary and appropriate procurement steps and be communicated to TxDOT.

Ms. Homfeld was also asked to find out who was in need of emergency transit services. She spoke to the DaVita Dialysis Centers in McKinney and Wylie and found there were only two patients from each center that require rural transit services. They found through TAPS' (Texoma Area Paratransit System) data that there were three other dialysis centers in the County. Ms. Homfeld has not spoken to those centers yet since she just received the information. COG has estimated \$80 per round trip with each patient requiring three trips per week. Assuming two patients each for the five dialysis centers, the cost for one month would be \$9,600. This is only an emergency solution until the interim solution is determined.

Commissioner Williams visited with the church in Lavon regarding the two dialysis patients in Farmersville and will visit with some potential volunteer groups for the two patients in Wylie. The Commissioner stressed that the County needs to have a provider in place in order for TxDOT to cover these costs. In the short term it will be faster to get a non-profit involved to address the immediate need. Judge Self agrees with Commissioner Williams that, until the staff moves to find an interim solution, there are people willing to help during this emergency period. Commissioner Williams said we need to identify where the demand is and determine if the need is for one or more services. It is incumbent on the Court to define the appropriate level of service and decide if the program will handle medical emergencies only or include the elderly.

The interim and long-term solutions will be funded by TxDOT. Ms. Homfeld said TAPS data will show what types of services were provided in the past. Commissioner Webb asked if the program is restricted to medical emergency patients totaling approximately six, are there any restrictions on the type of provider the County could appoint. Since the number is so small, this service will not be attractive to any provider. The Commissioner is aware that the liability issue will drive this. Commissioner Hill is concerned that the County will not find a long term solution because the number of people needing service is so small.

Commissioner Williams said it is critical for the public to know that every incorporated city can determine their own future as to what they will or will not provide. Only member cities of DART (Dallas Area Rapid Transit) automatically get some kind of transit or paratransit for the disabled, elderly and indigent. The cities will make that decision without the County's participation or input. The County only has a say in what happens in the rural area which is large in geography but small in population. Judge Self said the Court needs to work quickly to identify all of the needs regarding dialysis and then determine the level of service. We need to work with private sector for now and then determine the interim solution.

There was a brief discussion regarding focusing only on service for dialysis patients when there may be others with medical concerns that are genuine and need transportation. Since the County is not legally required to provide this service, the Court needs to know if it can discriminate between illnesses and only provide service for dialysis patients. Since this is a federal program, Commissioner Webb believes TxDOT will have guidelines that will need to be met. Ms. Homfeld will check into this and inform the Court. (Time: 2:30 p.m.)

Commissioner Webb said there were some TIP (Transportation Improvement Modifications) approved at the last RTC (Regional Transportation Council) meeting.

The most interesting agenda item was TxDOT has moved forward with a new program initiated by the governor for congestion relief in urban areas. TxDOT identified approximately \$1 billion to \$1.3 billion in potential funding for the partnership with metropolitan areas of the State which consists of the urban centers in Houston, Dallas/Fort Worth, Austin, San Antonio and El Paso. The eastern subregion's share of the total funding is estimated to be approximately \$364 million. It is unknown if this is a one-time thing or if there would be more urban-area only money in the future. These funds cannot be used for toll roads

Based on this the RTC approved some congestion relief projects. The first is in the eastern subregion on the Southern Gateway which is I-35E and US67. This area is very congested with a high incidence of accidents. Another project would be the advanced construction of noise walls and the Skillman/Audelia interchange as it ties into the LBJ E project. Another project is the conversion of the HOV lane on US75 back to a shoulder and then turning it into a fifth lane during rush hour.

The last item of interest was the City of Irving requested consideration of funding for infrastructure requests associated with a potential large regional employer. There were many interesting comments on this and it was put on hold. The Commissioner said this would be on a regional basis and would pit communities that sit on the council together against each other. (Time: 2:38 p.m.)
