Items 4e2, 4e3 and 4e4 were discussed together. Commissioner Webb said government has the ability to file liens on private property and the ability to sell that property in the event liens are not paid. In this case, McKinney has decided to sell the properties at the tax minimum versus the higher amount bid on the properties. Normally the equity generated from a foreclosure sale would go to the property owner; therefore, Commissioner Webb was opposed to approving these items because it would take away the equity from the owner.

Commissioner Hill said in the past if there was a bid over the minimum price that bid had to be accepted. Because the County took formal action on a bid of \$12,000 would that compel the City to accept the bid. Bill Bilyeu, County Administrator, said as long as the price is equitable for all entities to receive what is due the bid has to be accepted. Policy is if the entity is made whole the County Judge is able to approve the bid without it going to court which is how the \$12,000 was approved. Mr. Bilyeu will ask Gay McCall to explain to the Court why these properties are laid out differently and how to move forward with the opposing bids. With no further discussion, items 4e2, 4e3 and 4e4 were held. (Time: 1:40 p.m.)

Commissioner Hill had a follow-up comment on this discussion. The Commissioner asked Mr. Bilyeu to speak with McKinney to see if their buyer would be willing to put in a matching bid. (1:50 p.m.)

Commissioner Fletcher pulled this item due to two small differences in the resolutions from Prosper and Celina. Clarence Daugherty, Engineering, came forward to discuss the project. This project has been in the works for a number of years and is a result of the two cities approving resolutions of support. The resolutions support the first phase of the project which will ultimately be a six-lane thoroughfare with grade separation and a service road. The first phase approved by Prosper and Celina consists of four lanes of roadway, one-half of the grade separation and the two-lane service road. The estimated cost for the first phase is \$16.6 million. The gap the County would need to cover for this phase is approximately \$600,000. Mr. Daugherty shared a few other options for the project with the recommended option being what was approved by the cities. He also requested the Court designate the firm of Birkhoff, Hendricks and Carter as the best qualified firm to design the project. This firm has worked with Celina for several years doing the preliminary engineering required to get the project to this point.

Mr. Daugherty said there was one slight difference in the resolutions. Prosper's resolution says they will maintain the grade separation on their side and Celina will maintain Celina's side. Celina's resolution says Prosper will maintain both sides. The project option recommended for the first phase includes only one bridge at this time on the Prosper side; therefore, the difference in wording is not an issue if approved. Mayor Ray Smith, Prosper, and Mayor Sean Terry, Celina, shared their support for the project. Mayor Terry said, long term, Celina knows maintaining the grade separation will be necessary but not in the present because the City does not have any tax base in place there.

With no further discussion, a motion was made to approve Engineering's project recommendation which includes \$600,000 from the County as well as the designation of Birkhoff, Hendricks and Carter, LLP as the most qualified engineering firm to design the project and further authorize Engineering to negotiate with the firm on the scope of services and design fee. (Time: 1:49 p.m.)

In this instance property rights are involved. In order for the property to be put back on the tax roll, to be able to be sold in the future, a deed from the County will be needed. 6. <u>AI-41059</u> Rural Transit Services, Commissioners Court.

Tracy Homfeld, Engineering, came forward with rural transit options for the Court's consideration. The options are: 1) create a new RTD (Rural Transit District); or 2) join an existing RTD close to Collin County. Option one has two sub options: a) administer the rural program in house; or b) contract with an existing RTD or MTA (Metropolitan Transit Authority) close to Collin County.

Rural transit funding is provided by TxDOT (Texas Department of Transportation) from federal and state matching dollars. Allocations are made at the RTD level, not on an individual county basis, unless a county is a stand-alone RTD. Allocations are based on each district's proportional share of population, land area and performance. Formula funding is allocated as soon as it becomes available. State funding for FY2016 has already been awarded. TAPS (Texoma Area Paratransit System) received the FY2016 dollars. Federal formula funding for 2016 will be approved through the Transportation Commission at their March or April meeting. The next scheduled distribution of state funding will be in June 2016. Federal funds will become available in 2017 following Commission action. Collin County would not be included in the allocation if the County does not join or create an RTD.

Discussion followed. Ms. Homfeld has spoken with most of the providers and they are interested in having discussions, but first the decision has to be made whether the Court wants to join an RTD or create one. Judge Self said multiple providers can be designated to service the County. He suggested Ms. Homfeld ask the providers which areas they would like to provide service to. Ms. Homfeld said the County may only need to pick one provider and that one provider could subcontract services. The Court could also create a district much like the Housing Finance Corporation in order to contract with an MTA. Contracting with an MTA could be on a limited basis or a turnkey basis where the MTA would handle all aspects of the operation and provide updates to the Court. The MTA could subcontract with the minor RTDs throughout the County. Commissioner Hill asked Ms. Homfeld to find out what liabilities the County would be open to if the MTA missed a step. Would the MTA be responsible or would the County be responsible as the district? Judge Self suggested comparing DCTA (Denton County Transit Authority) and DART (Dallas Area Rapid Transit), which are MTAs who could handle the full operation, and find out what they are willing and able to take on. (Time: 2:13 p.m.)

7. Al-33858 RTC monthly update, Commissioner, Precinct 4.

Commissioner Webb said the RTC (Regional Transportation Council) tabled the policy for possible employer location indefinitely. There was a small tweak to I-35 regarding managed lanes for Mobility 2040. Mobility 2040 will be up for vote in March.

The Cotton Belt Corridor has stayed the same. Addison's position remains rails only while other jurisdictions just want service. Mobility 2040 is trying to push DART (Dallas Area Rapid Transit) to accelerate the Cotton Belt Corridor. As of now it is scheduled to be completed by 2035. If DART cannot accelerate the project in the next four years other options will be looked at.

The Transportation Congestion Relief Program was approved for \$1.3 billion. Nothing has changed as far as project prioritization, but it did free up \$100 million for other big projects.

The 2017-2020 TIP (Transportation Improvement Program) is in draft form and is scheduled for approval in April. Collin County will need to get comments submitted soon on the proposed projects for 2017-2020.

A letter has been drafted to the Attorney General in regards to the lawsuits against Volkswagen, Audi and Porsche for emissions fraud. The letter requests that if any settlement funds are awarded they be disbursed to nonattainment regions for air quality projects and/or programs. There are 3,000 vehicles involved in the lawsuit in Texas with 467 being in Collin County.

The phase one plan for US75 will be approved by the RTC in March in order to move forward for federal approval. This phase involves converting the managed lane back to a shoulder and use it as a fifth lane during rush hour. (Time: 2:20 p.m.)
