Commissioner Fletcher asked David Bristol, Prosper EDC (Economic Development Corporation) and Corbett Howard, Celina EDC, to update the Court on planned development north of Highway 380.

Mr. Bristol came forward with Garrett Weaver, Interim Director of Prosper EDC, and presented a PowerPoint presentation on the population growth, demographics and development activity in and around the City of Prosper. The major developments are Windsong Ranch with 2,100 acres, Villages of Star Trail with 1,100 single family homes planned, Blue Star Gates of Prosper which is currently under development and Matthews Paradise, a billion-dollar mixed use development. Other smaller projects include Texas Health Neighborhood Care & Wellness Center, the Prosper Bank Building, two Kroger grocery stores, a Lowe's Home Improvement Center and a second fire station. Mr. Bristol said they appreciate the County's interest in helping with the bordering roads such as Frontier Parkway.

Mr. Howard presented his PowerPoint presentation on Celina's demographics and development plans stating FY2020 through FY2030 will be the decade of Celina. The footprint of Celina is 78 square miles which is larger than either Plano or Frisco. Development plans include 38,365 residential lots bringing the population at build out to 137,000. The Celina Regional Activity Center will be larger than Legacy Park in West Plano. With Toyota's headquarters and J.P. Morgan's corporate campus moving to the area there is a shift in job creation, and Mr. Howard said this will help fuel the growth in Prosper and Celina. On the first 580 units built in the Light Farms subdivision, the average cost per home is \$386,000.

The two most critical arterials are the southbound access roads from FM428 to Highway 380 and the Outer Loop. Mr. Howard stressed the importance of completing the section of the Outer Loop between the DNT (Dallas North Tollway) and Preston Road and said the return on the investment for the County is outstanding. There was a brief conversation about the need for the future north/south flyover on Highway 380 to help ease congestion. Commissioner Fletcher received a video from a commuter who sat through six cycles of lights on Preston Road trying to go north over Highway 380 at 2:00 p.m. (Time: 2:33 p.m.)

John Palmer, Gardner Capital, came forward with a PowerPoint presentation and to request two Resolutions of Support for its 2016 competitive tax credit funding application submitted through TDHCA (Texas Department of Housing and Community Affairs). Gardner Capital is a privately-owned family of companies with 25 years of experience in the housing industry using mixed finance to develop housing.

Gardner has proposed a scaled and collaborative community revitalization plan on a 22.6 acre property owned by Rex and Sherese Glendenning. The plan includes a new public park, Gala at Celina – a gated senior living community, and Provision at Celina - a multifamily (workforce) development. The planned site is located within walking distance of Old Downtown Celina and is intended to stimulate and attract new commercial and residential investment in the antiquated and underserved parts of the city.

Mr. Palmer detailed the plans for the two developments which will provide high-quality and affordable housing for community residents. Gardner Capital is a long-term build-and-hold owner of housing communities and has a reputation for implementation of the strictest residency requirements and quality property management standards necessary to sustain long-term community success. The direct and indirect economic benefits from the Gala and Provision at Celina developments include: \$35 million in total development budgets; \$19.5 million in local construction spending; 295 local construction and service jobs; \$4.7 million in post construction service spending; 82 post construction service jobs; and an estimated \$250,000 in property taxes per year.

Originally the 23 acres were listed in the city and this was confirmed by both CAD (Central Appraisal District) and the Collin County GIS (Geographic Information Systems) Department. During the application process, Gardner Capital was notified by the City of Celina that the property was annexed in 2004 but 30 days later it had been de-annexed. Mr. Glendenning purchased the property in 2006 and has been paying city property taxes since 2006. TDHCA rules require a Resolution of Support from both the City of Celina and Collin County. Gardner Capital has received the resolution from the City of Celina and a letter of support from Representative Scott Sanford. The Resolution of Support from the County will allow them to move forward with annexation, rezoning, the site plan and providing sewer/utilities to the property. Without these approvals the developer cannot move forward with the application for either of the tax credit community developments. Applications are due on March 1, 2016. (Time: 3:32 p.m.)

Rex Glendenning, the property owner, came forward to ask the Court to support the projects. Mr. Glendenning's contractual agreement with Gardner Capital is that he will support it as a landowner as long as the city supports it. (Time: 3:34 p.m.)

Chris Kincaid, Celina, also came forward to ask for the Court's support. Mr. Kincaid is a Celina firefighter/paramedic and unable to live in the city that he grew up in because it is out of his price range and there is no affordable housing. An affordable housing development would allow him to move back into the city that he serves and protects. (Time: 3:35 p.m.)

Celeste Cox, Executive Director for North Collin County Habitat for Humanity, came forward to speak in favor of the resolutions. According to the U.S. Census Bureau, in Collin County 34% of those living in poverty are children under the age of six. The average rent for a two bedroom apartment is \$943 per month. Affordable housing is not a luxury; it is a necessity. With their current funding support, Habitat for Humanity cannot serve all the families that need support. Tax credit housing is not public housing because it is done with a private developer, land and investors. The Board of North Collin County Habitat for Humanity supports these projects. (Time: 3:37 p.m.)
