Argyle Security is pleased to provide this security proposal for your review and consideration. All system components have a warranty for a period of one (1) year, unless otherwise specified, against all defects in material and workmanship. This proposal shall remain firm for period of (30) days from the submitted date. Argyle Security payment terms are net (30) days with progressive billing.

## ***Scope of Work***

### **Provide**

Remove existing Rauland Nurse Call System.  
Remove existing Rauland Nurse Call Master Station.

We will be controlling the existing devices.

52 Intercom Stations inside and outside of the medical cells.  
24 Dome Lights located outside the Medical Cells  
48 Toilet Alert buttons (one high and one low)  
24 Nurse reset key switch inputs.  
Add 10 additional input point for future Intercom Stations

We will be re using the existing field devices and wiring. We will update the programming on the existing Medical Security Control station to add the Nurse Call, Intercom system.

We will be removing the existing Rauland Nurse Call Head End equipment. We will be installing a new equipment rack with a new PLC, Intercom Amp, power supplies, network switch and all needed relays and terminals to re-land the existing wiring to the new equipment.

A new intercom interface unit will be provided at the Medical Control Station to allow the operator to talk and listen to the field intercom stations.

## **Exclusions and Clarifications**

### **Installation Requirements:**

Argyle will provide the necessary installation, termination and programming for the Nurse Call on to the system. The existing wire will be tested and identified for each location. Argyle will disconnect and terminate the existing wiring onto the new relay control boards. The system will be tested and training provided to the Security Staff on operations and controls.

If it is found the cable non-usable and requires additional cable to be pulled for homeruns, additional charges may apply.

### **Conduit and Cable:**

Argyle will utilize all existing conduit and wire for the field devices already operational on the system (call stations, key switches and intercoms). Conduit installation is excluded from this quotation.

### **Warranty:**

Argyle offers a standard one (1 year) (365 days) warranty on all labor and material included in this project. Components noted to have more than one year of warranty will be warranted by the manufacturer with a **[3]** year warranty. All system components provided in this proposal are warranted against all defects in material and workmanship. Any existing wire, components, devices or conditions will not be covered in the agreement.

### **Sales Tax:**

Sales Tax is not included in this proposal, if the facility is Tax Exempt please forward exemption letter for our records.

### **Training:**

MCS will provide training to the facility for Administration, Operator and Maintenance

### **Excluded: (if applicable to this installation)**

Installation of new conduit if needed

Repair to existing devices not functioning (quote on cost will be provided)

Our labor costs for any item outside this quote will be **\$125.00** per hour per man.
