GENERAL DISCUSSION

5. <u>AI-41400</u> Public outreach of limited access roadway study, Engineering.

Clarence Daugherty, Engineering, came forward with a presentation discussing the Future Mobility in Collin County. The number of slides has grown and Mr. Daugherty discussed options for shortening the presentation depending on the target audience. The main issue is to communicate what is needed in the way of mobility and why the LARs (Limited Access Roadways) are so important for mitigating future congestion.

Commissioner Webb has already used the presentation and, due to time constraints, will reduce the number of slides for his next presentation. The Commissioner also would like the Court to hire a consultant to do an analysis of the economic impact on businesses, municipalities and counties along a six-lane divided thoroughfare versus LARs. Data from this type of analysis would be of interest to cities like McKinney, Prosper and Frisco. Judge Self said Brett Fenster, IT, is getting that data for US380 within the limits of McKinney. The Judge suggested asking TTI (Texas Transportation Institute) for this study. Mr. Daugherty will contact TTI.

There was a brief discussion regarding engineering, planning, funding and acquiring ROW (Right of Way) for the projects. Judge Self said it is the Court's job to brief not only the city councils, but also civic and political clubs. Commissioner Webb is presenting to Plano City Council, the Chamber, rotary clubs and some Lions Clubs within Plano.

The Court made changes to some of the slides, and Commissioner Hill suggested giving the Court all of the slides and letting them determine which to use depending on their target audience. Judge Self presented two slides which showed that the County's growth is the key to funding for these projects. (Time: 2:12 p.m.)


