1. Judge Self called to order the meeting of the <u>Collin County Commissioners' Court</u> at 1:57 p.m. and adjourned the meeting at 2:36 p.m.

President Self called to order the meeting of the <u>Collin County Housing Finance</u> <u>Corporation</u> at 1:35 p.m. and adjourned the meeting at 1:57 p.m.

President Self called to order the meeting of the <u>Collin County Health Care</u> Foundation at 2:36 p.m. and adjourned the meeting at 2:36 p.m.

GENERAL DISCUSSION

5. Al-33858 RTC monthly update, Commissioner, Precinct 4.

Commissioner Webb updated the Court on the last RTC (Regional Transportation Council) meeting. The Project Milestone Policy was passed. This is a policy which states if a project has not moved forward in the last ten years, the funds could be pulled and used on other projects. NCTCOG (North Central Texas Council of Governments) staff has worked with local agencies trying to justify keeping projects that are still of interest. Agencies that wanted to keep their money for old projects were required to confirm the project, provide documentation of local match availability, and provide a realistic schedule showing they would get the project done within the next three years. Frisco was the only city to return money on a project. Other than the Frisco project, Collin County did not lose any money as a result of the adoption of the policy.

Another item of interest was the Waco MPO (Metropolitan Planning Organization) gave a presentation primarily focused on I-35. Most of I-35 south of Waco has been or is being widened to three lanes on each side, and the only section left to be widened is from Waco north to Hillsboro. The Waco MPO and the RTC will work together to try to find funding to widen this section.

The 2016 FASTLANE (Fostering Advancements in Shipping and Transportation for the Long-term Achievement of National Efficiencies) Grant Program was approved. This program is designed to address congestion on the nation's freight corridors and to support anticipated freight growth in the multimodal transportation system. The RTC submitted two projects: the I-35E Phase II which is north of Denton and the DFW Connector around the airport. These two projects totaled \$200 million in requests

The 2016 TIGER (Transportation Investment Generating Economic Recovery) discretionary grant program was approved. Final applications are due by April 29, 2016.

The NTTA (North Texas Tollway Authority) paid the region \$3.2 billion in regional toll road funds to build the SH121 toll road. The NTTA will take 1% or \$3.2 million of regional toll revenues and use it to fund environmental issues since compliance with the federal government is becoming a much bigger issue. Commissioner Webb will find out exactly where these funds will come from.

There was also a presentation on the progress of the high-speed rail initiatives for the Dallas-Fort Worth region. Everything is moving rapidly and should move toward implementation within the next year and a half. The big issue is whether TxDOT will have its funding to connect Dallas to Arlington to Fort Worth.

Lastly, NCTCOG purchased bicycle and pedestrian count data collection equipment in 2014. After a full year of collecting data on the utilization of the trails by bikes and pedestrians, the report shows tremendous utilization with over 4 million counts in 2015. The City of Allen will purchase two counters to start collecting usage data on its trails. (Time: 2:18 p.m.)

6. <u>AI-41472</u> Sales Tax Transportation Reinvestment Zone, County Judge.

Judge Self thanked Bret Fenster, GIS, for putting the analysis together. The areas of interest are the DNT (Dallas North Tollway) between the President George Bush Tollway and US121, US75 between I-635 and US121, and US380 within the boundaries of McKinney. The DNT average yearly increment of state sales tax was \$15 million per mile. The average yearly increment per mile on US75 was \$9 million and \$2.5 million on US380.

The DNT sales tax projection for this 5.5-mile corridor grows by 14% every year. The projected sales tax growth from 2015-2034 is \$6 billion. The US75 sales tax projection for the 18-mile corridor grows by 10% every year with a projected sales tax growth over the same twenty years of approximately \$7.5 billion. US380 is our first priority and would benefit the most from this program. The projected sales tax growth for this 13.1-mile corridor from 2015-2034 is \$12.6 billion. However, this needs some analysis to determine where the plateau would be.

The property values in these corridors are also going to grow and that will be of interest to the state legislators since school financing is something they need help with every year. Judge Self feels the Court should be invested in this program and needs to help find state and federal dollars for our transportation. We've had \$1 billion spent in this county and only \$250,000 has come from state and federal dollars. Historically we do not get much from the RTC (Regional Transportation Council.) Transportation has been the defining force in economic progress since the beginning of time. Modern economies are defined by accessibility and logistics, and superior transportation offerings are a critical factor in the competitiveness and success of a region.

Judge Self said the plateau for the current US380 needs to be determined. The plateau analysis would be used to develop the timeline to determine future development needs and to get better estimates of potential growth. Our LARs projects need to be on every transportation plan and we need to brief every group that will listen. Commissioner Williams said the plateau will be different depending on how they treat US380. If it remains a surface street the potential growth is much more limited. Commissioner Webb said there is a huge discrepancy in property values per mile when comparing a LARs versus a six-lane divided highway. The Judge asked Clarence Daugherty, Engineering, to find a firm to do an economic analysis for these projects before the next legislative session. Mr. Daugherty agreed and said there needs to be a consensus on US380 and the Court needs to talk with the city councils. (Time: 2:36 p.m.)
