#### **GENERAL DISCUSSION**

**5.** <u>AI-41464</u> Transit Services for Rural Collin County presented by Denton County Transportation Authority (DCTA), Engineering.

Jim Cline, President of DCTA (Denton County Transportation Authority), came forward with a presentation on DCTA and transit options for Collin County.

In FY2015 DCTA carried nearly three million passengers on its bus and rail services. DCTA provides a broad variety of services such as the A-train commuter rail, vanpools, local fixed routes, university shuttles and paratransit service. DCTA wants to be a part of the region as it tries to partner with DART (Dallas Area Rapid Transit) and The T (Fort Worth Transportation Authority) when it makes sense.

DCTA was established under Chapter 460 of the Texas Transportation Code in 2001 with the sales tax elections held in 2002. In 2011 revenue service began on the A-train between Carrollton and Denton. DCTA is governed by a 14-member appointed Board of Directors made up of representatives of Denton County, large cities, small cities and the County at-large. Because of the broad representation that goes beyond the member cities of Denton, Lewisville and Highland Village, there is a special voting requirement when there is budget action or significant issues brought before the Board. Two of the three member cities must be present for the vote.

Proposed governance for potential Collin County services include: a full cost recovery contract for service; a service and cost containment strategy; the ability to leverage DCTA leadership and support; and have the Commissioners' Court define service parameters. DCTA's enabling legislation allows it to contract for this type of service.

DCTA is proud of its sustained financial strength. DCTA has 90 days of operating reserve in the bank, sets aside 3% of its sales tax revenue, sets aside \$50,000 for fuel in the case of a fuel cost spike, and has \$2 million of capital reserve set up. The internal coverage ratio is 1.31 which is higher than the target of 1.25. DCTA makes sure the current year revenue exceeds the current year expenditures. It has a positive net cash flow and runs a 20-year cash flow model to insure they are prepared for the future which is greater than the five-year cash flow model set by the Board. DCTA has received clean audits and a number of finance awards.

DCTA has existing service contracts with North Central Texas College, the University of North Texas and the City of Frisco. A variety of services are provided to meet their specifics needs. DCTA has the staffing capacity to manage an incremental increase in service and is structured to be scalable to address demands based on service requirements. DCTA is committed to providing cost-effective service in any area it serves. It is focused well on how to handle a growing suburban area to deliver a full range of services including on-demand services. DCTA would recommend Collin County utilize a "building block approach" beginning with a safety net of taking care of those who must have service, then building upon this as the County deems appropriate.

Key considerations for Collin County service include the fleet, the establishment of an RTD (Rural Transit District), how the finance and organizational structure will be set up, and what is needed for long-term service. The next step would be to work with Collin County to tailor the best solution. The primary concerns DCTA shares with the County are how to factor funding from an RTD into the service without creating a burden on DCTA, the County or any other entity and how to meet and sustain the demand of a fast growing area.

Judge Self said the Court is concerned with retaining local control once an RTD is established. There was a brief discussion on DCTA's ability to contract with other entities. The County would like to access the state and federal rural transit dollars that do not require a match and are only available if there is an RTD. The key is to figure out how to access those funds through an RTD which is not like a UZA (Urbanized Area) who contracts or has the match available. Mr. Cline will find the answers to the Court's questions about retaining local control and access to the state and federal funds assigned to the RTD without matching requirements. Judge Self would also like Mr. Cline to find out if there is a RTD in Denton County. Mr. Cline will report his findings to the Court's staff. (Time: 1:55 p.m.)

Judge Self gave a brief overview of the Comprehensive Economic Development Strategy PowerPoint presented to the Executive Board of the NCTCOG (North Central Texas Council of Governments).

Judge Self explained the EDA (Economic Development Administration) is a subset of the Department of Commerce. The EDA wants NCTCOG to develop an EDD (Economic Development District) which is a conduit for federal grants and Public Works & Economic Adjustment programs. This district is required in order to receive Public Works or Economic Adjustment Assistance grants. To have a district there must also be a CEDS (Comprehensive Economic Development Strategy). NCTCOG is the only COG (Council of Governments) that is not an EDD within a five-state region.

The Judge showed a list of grant applications submitted by the NCTCOG region to the EDA over the past decade. Of the 38 applications totaling approximately \$31 million, only five applications totaling a couple million dollars were accepted. The Houston-Galveston COG EDA funded projects totaled \$26 million, and the Alamo Area COG EDA funded projects totaled \$28 million.

Judge Self reviewed some of the goals and objectives for strategic direction. NCTCOG said they must have this to get grants, but the grants are small. There was a unanimous vote to put in the CEDS which was approved by the EDA. NCTCOG is asking for a letter of support but Judge Self recommended not putting in any more support for this. This will happen whether or not the Court supports it. The County will still be a part of it whether or not the Court supports it. Commissioner Webb asked if NCTCOG will direct this or a Board. Judge Self said it will most likely be a standard Board under the NCTCOG. NCTCOG will provide the staff and the Board will consist of entities. The Court agreed to not send the letter of support. (Time: 2:11 p.m.)
