Bill Bilyeu, County Administrator, explained that the FCC (Federal Communications Commission) has issued new guidelines to inmate phone companies regarding hidden fees and calling rates. As a result, vendors must eliminate all hidden fees and operate on calling rates and commissions paid. The County's phone vendor, Securus Technologies, has proposed three options for consideration in order to comply with the court rulings. Christina Clay, Account Manager for Securus Technologies, explained the options. They are: 1) increase the per minute calling rates; 2) decommission a portion of our current rate; or 3) take a cash deduction of \$11,158.00 per month from our commissions which represents a 26% reduction. After a brief discussion regarding the options, Judge Self recommended holding this item for one week to get more information. (Time: 6:12 p.m.)

GENERAL DISCUSSION

5. <u>Al-41610</u> Allowance of an Open Bar during the Farm Aid Event scheduled for October 14, 2016 at Myers Park & Event Center, Special Projects.

Robert Lyford, Market Chef at Patina Green Home and Market in downtown McKinney and member of the Advisory Board for Farm Aid, addressed the Court. Mr. Lyford gave a brief description of Farm Aid's role in helping farms after a disaster. This year \$10,000 of the proceeds from the event will be put into a grant fund to go back into the community hosting the event.

The event scheduled at Myers Park is part of a small event series hosted by Farm Aid. Our current policy states that alcohol consumption is limited to beer, wine and margaritas via a machine only. One of the major sponsors of the event is Prairie Organic Spirits which is a farm-owned spirit company that gives proceeds back to small family farms. If they cannot serve spirits at the event, Farm Aid will move the event to Dallas instead of Collin County. There will be two price points for admittance to the event - \$250 to \$350 for VIP tickets and \$75 for general admission. Admittance will be limited to 300 people.

There were brief discussions regarding insurance coverage and the fact that this is a non-profit event. Farm Aid will provide additional security and every bartender will be TABC certified. With no further discussion, a motion was made to approve the item. (Time: 6:44 p.m.)

7. <u>AI-41585</u> Bond Presentation, approval to authorize the sale of \$30,782,000 in Road Bonds and \$2,300,000 in Parks & Open Space bonds for a Total Bond Sale of \$33,082,000 and further authorize advanced refunding on eligible portions of the 2008 Limited and Unlimited Tax Issues, Budget.

Monika Arris, Budget, presented a PowerPoint presentation on the Collin County Bond Update. Outstanding bond issues prior to 2003 include \$1.15 million budgeted and allocated to an outdoor camp and \$395,000 remaining in road contingency. Tax Notes outstanding projects total \$7.4 million which is budgeted and allocated to various projects. Outstanding projects for the 2003 Bond Authorization include \$5.7 million budgeted for road projects, \$107,088 budgeted for facilities projects and \$32,109 remaining in Open Space contingency. Of the 2007 Bond Authorization, \$29 million has been awarded to cities within Collin County. There is \$1.6 million remaining in contingency for road projects and \$2.26 million for Parks & Open Space projects. Funds remaining in completed projects will be returned to contingency unless requested for another project.

2016 Requests for Funding include \$30,782,000 for Transportation funding divided among seven cities for planned projects and \$2.3 million for Parks & Open Space funding. The certified estimate provided April 30, 2016 shows a net taxable increase of 10.2% from last year's certified value. The adjusted taxable value is estimated to increase 9.3% from last year's certified value. Also requested is approval to authorize advanced refunding on eligible portions of the 2008 Limited & Unlimited Tax Issues and a Parameter Bond Sale.

Ms. Arris then presented multiple tax rate analysis scenarios. Judge Self would like to see the \$1.6 million that is not currently allocated to a project go toward the Myers Park vision. There was a lengthy conversation regarding cash funding projects instead of selling bonds. David Medanich, First Southwest Company Municipal Financing, said our tax rate would drop if we don't sell the bonds and that would affect what can be done in the future regarding selling additional bonds. Commissioner Webb is concerned that cash funding will impact the County's ability to fund the short fall in transportation needs. With no further discussion, a motion was made to approve the three actions. (Time: 7:11 p.m.)
