#### **GENERAL DISCUSSION**

**6.** <u>Al-41877</u> Functional Analyst Support of Constable Precincts presentation, Information Technology.

Caren Skipworth, CIO, presented an update on the Functional Analyst support of the Constable precincts for FY2016. Goals included: 1) equal accessibility of the Functional Analyst across all Constable precincts; 2) improved communication across all precincts: 3) managed and prioritized projects, tasks, and day-to-day support of Odyssey across all precincts; 4) set standard processes; and 5) IT requirements addressed which were outside of Odyssey. Goals were accomplished by setting monthly Constable meetings. Eight meetings have been held so far. Within those meetings direction and monthly priorities were set and initiatives were outlined. Two quarterly administrative meetings have been held so far to share information on specific office functions related to Odyssey. Twice yearly onsite precinct meetings led by the Functional Analyst have been held which included Constable staff, office clerks and IT.

The following are FY2016 accomplishments: The Constable Civil Paper Online Search is in production. The search shows civil paper details, when papers are received and the status of attempts served. The information remains online 30 days past the closure date of the case. The Active Warrant Search is in production which is part of the established Judicial Online Search that allows the search of any open and active warrants by name, case number, traffic citation or by attorney. The Constables were also introduced to SharePoint in order for the precincts to have a central repository for information sharing. Some of the other items accomplished in FY2016 include: 1) an Unserved Pending Civil Paper Report which is a listing of all pending paper by date range assigned to deputies; 2) an Odyssey clean-up of forms, prompts, data and security; 3) the updating of wearable cameras which is still ongoing; 4) stat tracking was moved into Laserfiche which helps with standard reporting to Budget; and 5) the GIS (Geographic Information System) mapping layer was added for Constables to map their paper routes.

Recommendations for FY2017 include: 1) reducing meetings to monthly administrative clerical meetings; 2) establishing an Administrative Constable; and 3) establishing project teams for future Constable projects.

FY2017 recommended projects include: 1) in-car cameras; 2) adding new Odyssey functionality which is a CJIS (Criminal Justice Information System) Soft Code requirement; 3) setting up after hours navigation via email and phone for issued papers by courts to Constables; 4) setting policy for the Reserve Officer MDCs (Mobile Data Computers) for Odyssey; 5) installing ICS (Incident Command System) Incident Management software for 911 dispatch on Constable MDCs; and 6) setting standards for Odyssey Financial Manager for all Constables with the assistance of the Auditor's Office. Some of the listed projects are pending the Court's discussion and adoption of the FY2017 budget. (Time: 1:49 p.m.)
