BY AND BETWEEN COLLIN COUNTY, TEXAS AND

THE NORTH TEXAS MUNICIPAL WATER DISTRICT FOR

PARTICIPATION IN THE COUNTY MONTHLY CLEAN-UP PROGRAM

THIS AGREEMENT is made and entered into by and between Collin County, Texas (hereinafter referred to as "COUNTY"), and the NORTH TEXAS MUNICIPAL WATER DISTRICT, a conservation and reclamation district located in Wylie, Texas, (hereinafter referred to as "NTMWD").

WHEREAS, County and NTMWD are both engaged in the provisions of governmental service, namely solid waste collection and disposal, for the benefit of the citizens of County; and

WHEREAS, NTMWD provides solid waste disposal services for its member cities, including Plano, Richardson, Frisco, Allen, and McKinney, and County currently operates a monthly clean-up program; and

WHEREAS, County wishes to expand its current monthly clean-up program and relocate the program to the NTMWD 121 Regional Disposal Facility, and

WHEREAS, the expansion of the County Clean-up Program is beneficial to NTMWD and the County and contributes significantly to the diversion goals of the State of Texas; and

WHEREAS, County and NTMWD mutually desire to be subject to the provisions of Chapter 791, et seq. of the Texas Government Code, the Interlocal Cooperation Act, and other applicable sections, statutes, and contracts pursuant thereto; and

WHEREAS, NTMWD has current funds available to satisfy any fees owed pursuant to this Agreement.

NOW THEREFORE, County and NTMWD, for the mutual consideration hereinafter stated, agree as follows:

I. EFFECTIVE DATE

The effective date of this Agreement shall be October 1, 2005.

II. TERM

The term of this Agreement shall be for the period beginning October 1, 2005 and ending September 30, 2006. Thereafter, and upon mutual agreement of the parties hereto, this Agreement may be renewed for successive one (1) year terms commencing on October 1 of each year, unless terminated by either Collin County or NTMWD as set forth below.

III. PAYMENT/TERMS/FISCAL FUNDING

Fees for the clean-up program will be determined by the NTMWD as a result of the preparation of the annual solid waste system budget. The County will be notified of the rate effective on October 1 of each year.

All fees will be billed to the County on a monthly basis.

IV. TERMINATION

This Agreement may be terminated at any time, with or without cause, by either party giving sixty (60) days advance written notice to the other party.

V. NOTICE

Notice as required by this Agreement shall be in writing delivered to the parties via facsimile or certified mail at the addresses listed below:

Each party does hereby agree to waive all claims against release, and hold harmless the other party and its respective officials, officers, agents, employees, in both their public and private capacities, from any and all liability, claims, suits, demands, losses, damages, attorneys fees, including all expenses of litigation or settlement, or causes of action which may arise by reason of injury to or death of any person or for loss of, damage to, or loss of use of any property arising out of or in connection with this contract.

In the event of joint or concurrent negligence of the parties, responsibility, if any, shall be apportioned comparatively in accordance with the laws of the State of Texas without, however, waiving any governmental immunity available to either party individually under Texas law. County shall be responsible for its sole negligence. NTMWD shall be responsible for its sole negligence. The provisions of this paragraph are solely for the benefit of the parties hereto and are not intended to create or grant any rights, contractual or otherwise, to any other person or entity.

VII. ENTIRE AGREEMENT

This Agreement represents the entire and integrated agreement between County and NTMWD and supersedes all prior negotiations, representations and/or agreements, either written or oral. This Agreement may be amended only by written instrument signed by both parties.

VIII. VENUE

The laws of the State of Texas hereto, shall govern this Agreement and any of its terms or provisions, as well as the rights and duties of the parties, and this Agreement is performable in Collin County, Texas. Exclusive venue shall be in Collin County, Texas.

IX. SEVERABILITY

The provisions of this Agreement are severable. In the event that any paragraph, section, subdivision, sentence, clause, or phrase of this Agreement shall be found to be contrary to the law, or contrary to any rule or regulation having the force and effect of the law, such decisions shall not affect the remaining portions of this Agreement. However, upon the occurrence of such event, either party may terminate this Agreement by giving the other party thirty (30) days written notice of its intent to terminate.

The undersigned officer and/or agents of the parties hereto are the properly
authorized officials and have the necessary authority to execute this Agreement on behal
of the parties hereto. NTMWD has executed this Agreement pursuant to duly authorized

October 14 , 2005.
