



AMENDMENT

This amendment ("Amendment") is effective as of the date of signature of the last party to sign as indicated below ("Effective Date"), by and between Tyler Technologies, Inc. ("Tyler"), a Delaware corporation with offices at 5101 Tennyson Parkway, Plano, TX 75024, as successor-in-interest to Brazos Technology Corporation ("Brazos"), and Collin County, Texas ("Client") with offices at 2300 Bloomdale, Suite 3160, McKinney, TX 75071.
