Bond funds are much more flexible and Plano could use those bond funds on other projects. Commissioner Webb said the City of Plano has a tendency to submit their ILAs (Interlocal Agreement) after the fact and this project has been going on for almost three years. This would have had to be submitted as a CMAQ project before the construction started.

Clarence Daugherty, Engineering, said the cities have been using what was in the bond program. Commissioner Webb suggested trying to have the cities substitute CMAQ funds for eligible projects as opposed to using bond funds and Judge Self agreed. #### **GENERAL DISCUSSION**

**5.** <u>AI-38983</u> North Central Texas Council of Governments (NCTCOG) Executive Board monthly update, County Judge.

Judge Self said he voted against the Annual Fiscal Plan at the COG (Council of Governments) because he routinely votes against at least one item every month and it adds up to quite a bit. Much of what the COG does, the Judge does not think COG should be doing. Judge Self said it may be time to consider asking the Governor to redraw the COG boundaries. The Governor has the authority to redraw the boundaries in a way that makes sense. Our current COG controls transportation dollars for more people than 75% of the State Departments of Transportation in the nation.

The next item of interest was NCTCOG recently sought bids for medical equipment and supplies and received only one bid. The Judge asked why there was only one bid but has not received an answer yet.

The last item was the Scoot Your Commute program. The RTC (Regional Transportation Council) was going to subsidize tolls and pay for advertising to try to move people off the road during peak rush hour periods. The City of Dallas representative on the Executive Board had an issue with subsidizing tolls. It was decided to spend the COG money on advertising the program only and not subsidizing tolls.
