#### PROBLEM IDENTIFICATION AND SOLUTION

#### I.Problem Identification

Drinking and driving is a major public safety threat, resulting in DWI-related accidents and making enforcement critical. The number of vehicles and drivers in Collin County (pop. 885,241) has increased corresponding to the 80.4% population increase since 2000. According to Texas Department of Transportation statistics, Collin County has consistently ranked in the top 10 counties for alcohol-involved crashes over the past decade, peaking at 681 crashes in 2009. From 2013 to 2014, alcohol-involved crashes increased for Collin County by 10.8% but decreased statewide by 4.3%. Additionally, over the same period, the percentage of alcohol-related fatalities increased in Collin County by 14.3% while falling 4.9% in Texas. In 2014, DWI-related fatal crashes in Collin County accounted for 35.6% of all fatal crashes while only accounting for 29.0% in Texas. Over the 4 year period from 2011 to 2014, the number of alcohol-involved crashes in Texas increased by 0.8%, while Collin County saw an increase of 24.3%. Additionally, over the same 4-year period, the number of alcohol-involved crash related fatalities stayed relatively the same for Texas, while fatalities increased by 45.5% in Collin County.

#### **II.Problem Solution**

In an effort to reduce the number DWI offenses and resultant roadway accidents, Collin County will continue our No Refusal Program, originally implemented in 2010, which weaves together public awareness, enforcement, and effective prosecution. According to 2014 TxDOT data, more alcoholinvolved crashes are reported from Friday to Sunday and between 11 pm to 3 am than any other days or times, while the 2007 National Roadside Survey (NRS) showed that 12.4% of drivers on weekend nights have a positive blood alcohol concentration (BAC) exceeding .08 g/dL (Lacey et. al., 2009).

Through the No Refusal Program, Collin County funds health care professionals on weekend nights and holidays at two local jails, provides increased public awareness through public/press releases, coordinates on-call judges, and ensures local law enforcement officers are aware of judicial and health care professional availability. The program provides law enforcement entities in the county the opportunity to obtain blood samples from drivers who refuse BAC testing, once a warrant is obtained. These No Refusal policies in turn provide prosecutors with scientific evidence confirming the driver's blood alcohol concentration when it would otherwise not have been available, thus improving prosecution.

Definitive evidence, such as BAC, improves DWI case conviction rates and enables prosecutors to recommend the most just and fair punishment, including increasing penalties for subsequent offenses, available under the law. Data from the Collin County District Attorney's (DA) Office shows that cases with no BAC evidence ("refusals") result in a substantially higher percentage of trials being requested (25.3% vs. 7.9%) and have correspondingly higher acquittal rates (17.4% vs. 4.0%) as compared with cases where BAC data is obtained.

In the past five years (January 2011 to September 2015), Collin County has prosecuted 8,953 DWI cases. Of those, BAC data was not collected/refused for 1,573 (17.6%) defendants. Of these "refusal" cases, trial

was requested in 398 cases, which resulted in 273 persons (68.6% of refusal trials) being acquitted. Comparatively, when BAC evidence was available the percentage of persons requesting trial and the percentage acquitted are reduced. This data demonstrates that a larger percentage of defendants who know scientific BAC evidence will be used during criminal proceedings are likely to plead guilty, whereas cases without BAC evidence are more likely to request trial and be acquitted by judges and juries.

Since the inception of the blood warrant program, Collin County has reduced the number of suspected DWI cases being prosecuted without BAC evidence from 29.2% in 2011 to 7.9% in 2014 as both blood consent and blood warrant cases have increased. Alternatively, this can be stated that the collection of BAC data has increased from 70.8% in 2011 to 90.6% in 2014 with the No Refusal Program. This has corresponded to an increase in the overall conviction rate, from 91.1% in 2011 to 95.5% in 2014, for DWI cases as the conviction rate for cases with BAC evidence is higher (96.0%) than for those without it (82.6%). Extrapolating from this data, without the program, an estimated additional 306 acquittals would have been expected in Collin County since program inception.

The No Refusal Program has ensured that DWI offenders in Collin County are penalized to the extent possible with fewer requests for trial and higher conviction rates resulting from scientific BAC evidence. Research shows that most (72.8%) weekend night drivers are classified as normative drinkers, as opposed to having an alcohol use disorder (Lacey et. al., 2009), and that the anticipated increasing severity of punishment resulting from subsequent DWI convictions tends to reduce recidivism for first time offenders (Hansen, 2013). Therefore, enforcement through conviction with documented blood alcohol concentration data should ultimately reduce the number of repeat DWI offenses and prevent future alcohol involved crashes.

## **III.Project Evaluation**

DWI case data will be collected and evaluated for trends. Case data will be analyzed by BAC type (refusal/none, breath, blood consent, blood warrant, and urine), as well as by case procedure (plea, jury trial, bench trial) and disposition (conviction or acquittal). The conviction rate for cases with BAC evidence is anticipated to be higher than cases with no evidence. Public should become more aware that enforcement will increase the likelihood of arrest and successful prosecution.
