Documents given to bidders to price and bid this project included the specifications and drawings. These represent the work that is expected by the Owner and ultimately the Work that becomes a part of the Contract. This is all the information that bidders have to bid from. These documents are attached to the Contract to represent the scope of work included. For the scope of work involving lighting controls, the information given to bidders by these documents left a hole in the scope of work or "scope gap".

The note on drawing E7.01 states that all building lighting shall be controlled via the building lighting control system type Douglas Controls. Contact Brad Stevenson (949-644-8889). It also states to reference lighting building control riser diagrams sheet E7.03 for lighting control details. There is no drawing E7.03.

The note on drawing E7.02 states that for further information to contact Douglas Lighting Controls and provides contact information for Douglas. So both drawings E7.01 and E7.02 refer to Douglas Lighting Controls to set the scope of work. Therefor Douglas Lighting Controls sets part of the scope of work since these notes both refer to them to obtain information needed for bidding and performing the work. No other vendor is listed.

During the submittal process it was discovered that Douglas Lighting Controls had not included any of the renovation work in the information given out at bid time. Therefore the costs for lighting controls for the renovation part of the project were not included in the bid.

We therefore ask for reimbursement I the amount of *Twenty Two Thousand, Eight Hundred Sixty Four dollars (\$22,864)* to cover costs for the lighting controls that were not included in the work. The scope of work set in the documents did not include this.

Dear Mr. Burke:

We have finalized the required quotations for PCO #072 R1 – Missing Lighting Controls for Renovation.

We have reviewed the scope of work and have verified that all extra work items are in compliance with our contract agreement. Attached is a detailed itemization of the extra costs. Total amount of this request is *Twenty Two Thousand Eight Hundred Sixty Four dollars* (\$22,864).

As noted in the renovation Electrical Drawings, note 1, it shows that bidders are to contact Douglas Lighting Controls for accurate counts of controls. This process was followed as there were no other alternate vendors allowed per specification. Only Douglas was shown and they were shown as to providing equipment counts. During the base bid, these items were left off and subsequently added after contract award during the submittal process. No alternates were provided for this scope, so Turner was forced to only get numbers from the missing scope for Douglas only. This took away any negotiation ability that Turner may have had. This PCO is seeking reimbursement to cover costs for these lighting controls that were not included in the base bid and not allowed to provide as an alternate.



# LIGHTING SEQUENCE OF OPERATION

- ALL BUILDING LIGHTING SHALL BE CONTROLLED VIA THE BUILDING LIGHTING CONTROL SYSTEM TYPE DOUGLAS CONTROLS. CONTACT BRAD STEVENSON (949-644-8889).
- œ EACH QUADRANT SHALL HAVE A LIGHTING CONTROL PANEL LOCATED IN THE QUADRANT'S DAISY-CHAINED TOGETHER VIA LOW VOLTAGE COMMUNICATIONS CABLE ELECTRICAL ROOM (16 PANELS TOTAL). ALL LIGHTING CONTROL PANELS SHALL BE
- S THE LIGHTING CONTROL PANEL LOCATED IN THE BUILDING'S MAIN ELECTRICAL ROOM SHALL BE CONSIDERED THE MASTER LIGHTING CONTROL PANEL. THE MASTER LIGHTING CONTROL PANEL SHALL HAVE AN INPUT DATA LINE FROM THE BUILDING'S ENERGY MANAGEMENT REMOTELY MONITOR AND CONTROL ALL OF THE LIGHTING CONTROL PANELS USING A SYSTEM (HONEYWELL). THE BUILDING MANAGEMENT SYSTEM SHALL HAVE THE ABILITY TO DOUGLAS CONTROLS INTERACTIVE DISPLAY.
- O ALL EXTERIOR LIGHTING SHALL BE CONTROLLED VIA PHOTOCELL ON AND TIMECLOCK OFF. EXTERIOR LIGHTING CONTROL PANEL SHALL HAVE A PHOTOCELL INPUT WITH A PHOTOCELL LOCATED ON THE BUILDING'S ROOF.
