Commissioner Hill led the Invocation.

1. Judge Self called to order the meeting of the **Collin County Commissioners' Court** at 1:30 p.m. and adjourned the meeting at 3:26 p.m.

President Self called to order the meeting of the <u>Collin County Toll Road Authority</u> at 3:26 p.m. and adjourned the meeting at 3:26 p.m.

2. Public Comments.

Ben Brown, Fairview, came forward to address the Court on HB 1271 which addresses uniform election dates. Mr. Brown said all elections, except those where an elected official must be replaced, should be held on a uniform election date as stipulated by Texas law. This saves taxpayer dollars, reduces confusion among the electorate, and eliminates the stealth elections that seem to be in vogue in Texas. Mr. Brown referenced SB 173 which also addresses uniform election dates. (Time: 1:34 p.m.)

4. Consent agenda to approve: Judge Self asked for comments on the consent agenda. Commissioner Williams pulled the group of indigent defense payments under item 4a. Commissioner Williams stated the Court indicated it would not pay any indigent defense costs that did not have back up available to allow each Commissioner to determine if those payments met the guidelines of the local rules and the Fair Defense Act. The Commissioner noted that the Auditor works for the Board of District Judges and not for Commissioners' Court. It is at the Board of District Judges' discretion whether or not the Auditor will be able to provide the Court with this information. It is the Commissioner's intent that, unless she can prove that each and every payment made to an indigent defense attorney meets the criteria in both the local rules and the Fair Defense Act, she does not intend to approve them. GENERAL DISCUSSION

5. AI-42567 FY 2017 Reclassifications, Human Resources.

Cynthia Jacobson, Human Resources, came forward with the market data associated with a request by the Justice Courts for the reclassification of their court clerks. Ms. Jacobson does not recommend the reclassification. Judge Paul Raleeh, Justice of the Peace, Precinct 1, came forward as the Administrative Judge for the five Justice Courts. The request is for the Justice Court clerks to be re-classed one pay grade up since their duties are very similar to those of the clerks in the County and District Courts.

Ms. Jacobson explained the County's pay philosophy and guidelines which this request did not meet. Commissioner Fletcher asked if the job functions were the same as the other departments and were they having trouble filling the positions. Ms. Jacobson explained they have no trouble filling the positions which are entry-level requiring no particular skill set.

Judge Raleeh said the job description of the Justice Court clerks mirrors that of the County and District Court clerks. Commissioner Williams said Judge Raleeh is looking for a policy change so HR can compare an existing job in the County with another existing job as opposed to comparing the same position with other counties. There was a lengthy conversation regarding the job descriptions, job comparisons and County policy.

Commissioner Williams said she had indicated during the last budget session that she would not approve any more re-classes until the Court fixed or attempted to fix the ongoing issues with compensation and compression. With no further discussion, a motion was made to approve all reclassifications except those not recommended by Human Resources. (Time: 3:05 p.m.)

7. Al-42773 Conference of Urban Counties update, Commissioner, Precinct 3.

Commissioner Hill updated the Court on the last CUC (Conference of Urban Counties) meeting. The CUC Policy Committee is reviewing bills and deciding which to support or oppose. The Commissioner voted "no" on six different items that were eventually passed.

The most discussed issue was SB 2 regarding property tax reform, and a majority of the members vehemently oppose any attempts to regulate property taxes or put reforms on the counties, cities or school districts. Don Lee, Executive Director, reported that he heard the House Ways and Means Committee was favorable towards passage of this bill. Commissioner Fletcher said it is critical that the bill include a normalization of the election date.

The next item discussed was SB 4 regarding Sanctuary Cities though there was no vote. Travis and Dallas Counties have taken positions directly against the Governor and against the focus of eliminating sanctuary cities. No vote was taken so this item may be on the agenda for the March 8 meeting.

There was unanimous support for both HB 1058 and HB 1258.

Next was a presentation on some ethics reform bills, specifically one presented by Senator Van Taylor from Collin County. Some members spoke against any ethics reform. Travis County said it was too punitive for elected officials who violate their ethics. The penalties against elected officials who violate the code of ethics included losing their pensions.

Commissioner Williams asked if there was a discussion on straight party voting. Commissioner Hill said there was but there were no passionate opinions on either side. There was a suggestion to end straight party voting for judicial elections and some members wanted to end it for all elections. There was no action taken and it was not mentioned whether or not it would be on the agenda for the next meeting. Commissioner Williams feels it is a huge mistake to not have straight party voting in Collin County, especially on down ballot races. (Time: 3:26 p.m.)

8. <u>AI-42768</u> Texas Transportation Forum update, County Judge.

Judge Self briefed the Court on a presentation by the state demographer at the Texas Transportation Forum. The population in Texas grew by 10.8% from 2010 to 2016. Eighty-six percent of the people living in Texas live to the east of I-35. Collin County is ranked 14th in the country for numeric growth, and 75% of that growth is from migration. The population in Collin County is growing by 3.2 to 3.5% each year.

The north and east parts of Collin County have the largest percentage for people with commutes of 40 minutes or longer. Collin County is one of the counties projected to grow by 30% or more every decade from 2010 to 2050. By 2040, Collin County's population will be at or above 2.5 million. Today Collin County's population is at 950,000. The population estimates project Collin County will surpass both Dallas and Tarrant Counties between 2045 and 2050. These are staggering growth projections. (Time: 1:43 p.m.)

9. Possible future agenda items by Commissioners Court without discussion.

Commissioner Williams said SB 292 is a bill for a jail diversion mental health grant which would make additional money available for jail diversion. Also, there is a bill from Senator Van Taylor requiring a tax assessor/collector to collect for NTTA (North Texas Tollway Authority.) The Court will discuss these next week. (Time: 3:15 p.m.)

10. <u>Al-42811</u> NCTCOG Collin County Roadway Action Plan Briefing, Commissioner, Precinct 3.

Commissioner Hill introduced Jeff Neal with NCTCOG (North Central Texas Council of Governments). Mr. Neal is a Program Manager for Corridor Planning Project Development. The Ten Year Plan is an annual collaborative performance-based apparatus for local governments and MPOs (Metropolitan Planning Organizations) to assist TxDOT (Texas Department of Transportation) with selecting and prioritizing roadway projects for the statewide UTP (Unified Transportation Program.) The North Central Texas regional project list was approved by the RTC (Regional Transportation Council) in December 2016. Approximately \$700 million was made available for the Collin County Roadway Action Plan. Major projects on this plan include north/south corridors, the Outer Loop from the Dallas North Tollway to SH121, the Outer Loop from US380 to the Rockwall county line and US380 and a potential McKinney bypass.

Mr. Neal presented the north/south roadway model assumptions for the west corridor, the lake corridor, SH78/SH205/John King and the Outer Loop. A screenline analysis was used to model each of these corridors to determine the daily volume at certain points on the roadways. More refined analysis will be done over time. Commissioner Williams noted these models were run assuming these roadways were six-lane principal arterials instead of LARs (Limited Access Roadways.) The modeling indicates that traffic will decrease on SH78 if the other north/south roadways are built.

Additional roadway modeling assumptions were conducted for the eastern alignment of SH121 also known as Spur 399 extension. This modeling was based on a six-lane freeway at 70 miles per hour from US75/Sam Rayburn Tollway to US380 east of Princeton. While the modeling shows the daily volume on this roadway will vary between 36,000 and 61,000, the major benefit is the 33% to 44% decrease in daily volume on US380 as a result of this roadway.

The next steps are to meet with elected officials, analyze potential refined alternatives and proceed with strategic review to identify possible expedited projects. Commissioner Hill would like to get as much ROW (Right of Way) now as possible. With the estimated population growth by 2040, even if all four of the modeled corridors are built, it will not relieve the congestion on US75. The corridors are inadequately spaced for both north/south and east/west routes, and more options are needed on the grid. Commissioner Williams confirmed there would also be modeling of some or all of these roadways as LARs.

Commissioner Hill said NCTCOG has another \$150 million for Collin County to be used for engineering and acquisition in addition to the \$700 million. The COG is ready and wants to move quickly if the County can get consensus on one or more of these projects. Commissioner Williams said one of the next steps would be for COG to provide this presentation to city councils. Commissioner Fletcher said her constituents want to make sure there will be no tolling on these roads. Mr. Neal said they are not anticipating tolls, and current funding for these projects would prohibit tolling.

There was a brief discussion regarding a bond election and having funding ready when Prop 7 money comes online. Judge Self asked if the plan could be changed to the Collin County Highway Action Plan (CCHAP). Commissioner Hill wants to make sure the modeling is based on the population at build-out and not the 2040 population. The Court needs to know what to set aside for the long term. Based on the demographic study, the county's population in 2040 will be approximately 2.5 million. However, at build-out the population will be closer to 3.5 million or more. The Commissioner wants to make sure that everyone knows what the ultimate goal is. (Time: 2:22 p.m.)
