d. <u>AI-42842</u> Supporting vehicle registration block for nonpayment of tolls by habitual violators.

Carrie Rogers, Director of Government Affairs at NTTA (North Texas Tollway Authority) came forward to address the Court. Vehicle registration block was authorized by Texas legislature in 2013 as a permissive authority for tax assessors. It has been left up to the tax assessors in each county to decide whether or not to implement this program. NTTA has worked with seven other counties to put in place a vehicle registration block ILA (Interlocal Agreement) whereby there would be a compensation structure per block that is accepted by DMV (Department of Motor Vehicles). That program is not currently in place in Collin County but the NTTA is eager to get something like that here.

Since the program has been implemented, NTTA has submitted approximately 40,000 blocks to DMV for Collin County habitual violators. A habitual violator is defined as someone having 100 or more unpaid tolls. So far this year the NTTA has submitted almost 2,400 blocks and are projecting 26,000 blocks by the end of the year. If all of these blocks are accepted by the DMV, that would be approximately \$138,000 in compensation to the County for participation in the program.

Commissioner Fletcher said it was her understanding there would be no real costs to the County to implement the program. Ms. Rogers said other counties have not increased their staff, and the majority of the work is on the part of NTTA interacting with the DMV.

Commissioner Webb changed the first line in the last "Whereas" paragraph in the resolution to "WHEREAS, Collin County Senator Van Taylor contemplates filing Senate Bill XXX during the 85th Texas Legislature". With no further discussion, a motion was made to approve the item. (Time: 6:12 p.m.)
