Michael Shaunessy, Attorney, came forward to address the Court. Mr. Shaunessy represents Jeff May, Auditor, with regard to the Auditor's responsibilities and abilities under the constitution and applicable statutes to make a determination relative to whether the Commissioners' Court should pay an indigent defense payment request pursuant to a court order. If Commissioners' Court is going to refuse to pay fees awarded to an attorney for representing an indigent party, the Commissioners' Court must either determine on its own that the award is unreasonable, arbitrary or capricious as to constitute an abuse of discretion, or take some action to challenge the order awarding the fees. The Auditor does not have the authority to say he will not present an invoice to Commissioners' Court for payment.

Commissioner Williams said the Court has never suggested the Auditor not present items for payment which have been signed by the courts. Commissioners' Court is trying to easily identify how those awards meet the plan and is not asking for information that would identify a person or a case. Mr. Shaunessy said they are working to get that information more easily and efficiently. Commissioner Hill's comments mirrored those of Commissioner Williams. A lengthy conversation ensued.

Judge Self said Commissioners' Court and district and county judges operate under state law so neither holds absolute power. The Court simply wants to know before it pays a bill

that it meets state law and the rules. Mr. Shaunessy said the Auditor is stuck in the middle, and he is trying to understand the demands on both sides and facilitate the process. The Judge suggested telling the lawyers to indicate what they are billing for and how it meets the plan.

Commissioner Webb said he has no issue as long as the judges indicate when they grant a discretionary bonus under §4 outside of the adopted Indigent Plan Fee Schedule and note that on their order. The Commissioner said the Court has to rely on the judges with regard to juvenile criminal cases since those are sealed. Commissioner Williams disagreed because the Court is merely asking for a notation regarding the charges per hour on the case as opposed to information on the sealed case. There was a lengthy conversation regarding the Auditor's ability to interpret the invoices. Mr. Shaunessy said the Auditor has worked with the Court enough that he is identifying the invoices that are obvious and will reach out to the district judges for those that are not. Commissioner Williams feels the Auditor is at a disadvantage because he is not getting clear information from the judges. Commissioner Hill is confident in the goodwill of the Auditor and the judges and that they will work together on this issue.

Mr. May updated the Court on the four disbursements on page 182 of the Court Packet that had been held for clarification. The payment to the Law Office of Mito Gonzalez for \$800 was reduced to \$450 by Judge Rippel to fit within the plan. The check to Meghan Miller was deleted because it was approved on a previous Court. Mr. May has not yet received a revised order from the judge regarding the check to Christopher Routt. Lastly, the payment to Wesley David Spencer for \$1,450 was reduced to \$1,000. After Mr. May and Commissioners Williams and Hill reviewed this, it was determined to be correct. With no further comments, a motion was made to delete check 453216, approve checks 452591 and 453665 and hold check 453214 for further explanation from the judge. (Time: 2:06 p.m.)

GENERAL DISCUSSION

5. Al-42955 Collin County Adventure Camp annual update, Administrative Services.

Neil Rosenbaum, Executive Director of the Collin County Adventure Camp, came forward with a PowerPoint presentation explaining the mission and programs available at the camp. These include Outdoor Education, Adventure Guide Programs, Retreats, and Scouting programs, a YMCA Day Camp, Family Camp, Community Days and a Resident Camp for the children of Collin County.

Over 27,000 people came to the facility last year. Outdoor Education has been the biggest percentage of revenue over the past ten years with over 13,000 children last year. The conference and retreat business has been slowly increasing. The summer day camp program has grown from approximately 530 children two years ago to 800 last year. They are expecting 1,000 this summer. Outdoor education has always been the primary purpose of the camp with 64% from Collin County schools, 25% from schools outside Collin County and 11% from private and home schools.

The YMCA has made a commitment to provide these programs to children regardless of their ability to pay. Last year \$173,414 in scholarships was provided to schools, groups and individual families. Funds raised through community support totaled \$21,070 with the balance of \$150,000 coming from the camp's operations funds. (Time: 2:23 p.m.)

6. <u>AI-42956</u> Installation of a Giant Swing to be located adjacent to the Zipline at the Collin County Adventure Camp, Administrative Services.

Neil Rosenbaum, Executive Director of the Collin County Adventure Camp, said a request was submitted to Commissioners' Court to build a giant pendulum swing to be paid for by the YMCA. This would be built in conjunction with the zip line tower at the camp.

Judge Self said there is \$6,000 in advertising for a waste water permit and asked if that could be moved to internet websites. Mr. Rosenbaum said he is required by TCEQ (Texas Commission on Environmental Quality) to post this in the newspapers with the biggest circulation in the County. Therefore, Mr. Rosenbaum was required to post this with the Dallas Morning News. The Judge would like to find out if internet websites could be used.

Commissioner Webb asked how the \$2.3 million in revenues for 2016 compared to previous years. Mr. Rosenbaum said revenues have gone up \$100,000 each year for the past two years, and 2016 has been their biggest year since the camp was opened. With no further discussion, a motion was made to approve the item. (Time: 2:27 p.m.)

9. <u>AI-38983</u> North Central Texas Council of Governments (NCTCOG) Executive Board monthly update, County Judge.

Judge Self updated the Court on the last monthly meeting of the NCTCOG (North Central Texas Council of Governments) Executive Board meeting. The first item of interest was a resolution authorizing an agreement between DART (Dallas Area Rapid Transit) and the COG to assist DART with TRIP (Transit Related Improvement Program). DART will provide \$20 million in local dollars to COG, and the COG will give DART the same in federal dollars. Commissioner Webb said federal funds have substantially more restrictions, and exchanging federal funds for local funds would give more flexibility in using those funds.

The next item of interest was a resolution authorizing grant applications to the DOE (Department of Energy) funding projects that accelerate the deployment and adoption of sustainable transportation technologies including electric vehicles and alternative fuels. The Judge stated that Texas will eventually become one of the largest oil producers in the world, and this resolution will expand the use of electric cars. Judge Self asked Commissioner Webb to ask about this at the next RTC (Regional Transportation Council) meeting. (Time: 2:33 p.m.)
