I. PURPOSE

The Department of State Health Services ("System Agency"), a pass-through entity, and **Collin County** ("Grantee") (each a "Party" and collectively the "Parties") enter into the following grant contract to provide funding for activities in support of the Cities Readiness Initiative ("CRI") under the Public Health Emergency Preparedness Cooperative Agreement (the "Contract").

II. <u>LEGAL AUTHORITY</u>

II. <u>Duration</u>

The Contract is effective on **July 1, 2017** and terminates on **June 30, 2018,** unless renewed or terminated pursuant to the terms and conditions of the Contract. The System Agency, at its own discretion, may extend this Contract subject to terms and conditions mutually agreeable to both Parties.

III. BUDGET

The total amount of this Contract will not exceed **ONE HUNDRED TWENTY-EIGHT THOUSAND SIX HUNDRED FIFTY DOLLARS (\$128,650.00).** All expenditures under the Contract will be in accordance with <u>ATTACHMENT B, BUDGET</u>.

Funding for this Contract is dependent on State Appropriations and Federal Grant funds. No work may begin and no charges may be incurred until the System Agency issues a written notice to proceed to Grantee. This Notice to Proceed may include an Amended or Ratified Budget which will be incorporated into this Contract by a subsequent Amendment, as necessary.
