This afternoon we staffed your diversion application for youth XXXX XXXXXXXX (**Redacted**) and it **was approved** for placement at G4S, but for 6 months versus 9 months, in the substance abuse treatment program instead of the general offender program. If at any time the department or the treatment team at G4S feels that XXXX XXXXXXXX (**Redacted**) will need to stay longer, then you can submit an extension request with an assessment from G4S explaining why there is a need for additional placement. As it relates to the aftercare that was listed on the application, can you provide some details as to what services XXXX & his family will receive? Such as family reunification, mentoring, re-entry, etc. The committee is interested on what levels of family engagement will be offered considering the dynamics in the home.
