GENERAL DISCUSSION

5. <u>AI-43041</u> Budget amendment in the amount of \$30,000 for professional services to define the requirements for replacement of a malfunctioning heat exchanger at the Collin County Adult Detention Facility, Facilities.

Bill Bilyeu, County Administrator, came forward to address the Court. The legislative requirements for this statute call for architects and/or engineers to be used for certain projects regardless of how unsophisticated the project is. If "X" amount of dollars are to be spent on a project, a licensed architect or engineer must review the project. Judge Self would like to put this on the legislative list to review for next session.

Commissioner Williams asked Mr. Bilyeu to start the legislative list for the next session. With no further comments, a motion was made to approve the item. (Time: 1:35 p.m.)

Commissioner Williams said there are some valuable changes that relate to mental health in this bill, but the remainder is very egregious as it relates to the burdens it places on law enforcement. Sheriff Skinner said the bill has not made its way out of committee yet, and Senator Whitmyer may have a similar bill. While the Sheriff agrees with the Sheriff's Association of Texas regarding the mental health aspects of the bill, the changes it calls for regarding search and seizure are completely unacceptable. Because of that, the Sheriff's Association and Sheriff Skinner are opposed to this bill. Commissioner Fletcher suggested having staff use the Sheriff's letter as a model and then creating a resolution of opposition to be signed by the Court. (Time: 1:42 p.m.)

Commissioner Williams said there are a few CDAs (Comprehensive Development Agreements) that have been proposed and no others would be allowed. She is concerned about opposing this as it relates to I-635.

Commissioner Webb agreed with Commissioner Williams and said this bill has moved out of committee. There is a lot of concern that if the I-635 CDA does not get approved it will suck up all the money in the region for the next ten years. Commissioner Hill said Collin County has paid more than its fair share in tolls for the transportation infrastructure in this county. The Commissioner will continue to stand against any move to toll other roads in Collin County, but if other counties want to do that, it frees up some dollars that could be available for Collin County. The Court agreed to remain silent on this bill. (Time: 1:45 p.m.)
