GENERAL DISCUSSION

5. <u>AI-43117</u> Accept the donation of portraits of Collin County heroes, Commissioners Court.

As part of the Collin County Fallen Warrior Portrait Project, R. D. Foster came forward to present six portraits of Collin County heroes to be put on permanent display in the "Hall of Heroes" at the Collin County Courthouse. The portraits are created by McKinney artist and US Air Force veteran, Colin Kimball, who donates his time and talents to this historic project. The following are the six heroes being honored:

Richard P. Rush, McKinney, Seaman 1st Class, US Navy, killed in action December 7, 1941 during the attack on Pearl Harbor.

Loyd McGraw, McKinney, Tech/Sgt. US Army, 99th Infantry Division, killed in action at the Battle of the Bulge in 1944 during WWII.

Lloyd R. McCrary, Farmersville, Pvt. 20th Combat Engineers, 49th Infantry Division, 7th Army, killed in action in Europe in April 1945 during WWII

Charles L. King, Prosper, Spc. 5th Class, US Army, 3rd Brigade, 47th Infantry Division, Mobil Riverine Force, killed in action on June 4, 1969 in South Vietnam.

Eric Duckworth, Plano, Staff/Sgt. US Army, 759th Military Police Battalion, 89th Military Police Brigade, died of wounds sustained when an improvised explosive device detonated near his vehicle in Baghdad, Iraq, on October 10, 2007.

Timothy Barber, McKinney, 4th Class Cadet at the US Air Force Academy, killed in a plane crash on December 31, 2016, in McKinney while home on leave.

Mr. Kimball thanked the Court for allowing the portrait project to keep the legacies of these men alive for future generations. He also thanked the families of the men for their support. With no further discussion, a motion was made to accept the portraits and place them in Courthouse. (Time: 6:07 p.m.)

6. <u>AI-43252</u> Planning Board recommendations for a Transportation Bond Program, Engineering.

Clarence Daugherty, Engineering, came forward and introduced Bill Moore representing the Planning Board. The Court had asked the Planning Board to look at available data and make recommendations regarding the need for additional LARs (Limited Access Roadways) in Collin County. The Board met 13 times, and on March 1, 2017, invited all the cities of Collin County to a transportation summit to discuss the issue. Responses from the cities were: (1) three resolutions of support; (2) no resolutions opposing; (3) separate resolutions supporting cost sharing of city thoroughfares; and (4) several cities informally (verbally or via email) expressed the desire for city thoroughfare cost sharing. The Bond Committee concluded that a city that did not send a formal response did not oppose a bond election. Discussions were very positive and, with the rapid growth in Collin County, everyone agreed there is a need for additional LARs.

Mr. Daugherty discussed the population estimates and projections for Collin County. Projections show the 2010 population will double before 2030, and by 2050 Collin County will be larger than Dallas County. The Court notified TxDOT (Texas Department of Transportation) and NCTCOG (North Central Texas Council of Governments) of the county's needs which included US380, SH78, a north/south roadway between US75 and Lake Lavon and the Outer Loop. TxDOT and NCTCOG then developed a Roadway Action Plan for the County. Regarding funding, \$602 million has been allocated in the Regional Ten Year Plan (UTP) Unified Transportation Plan for construction of Collin County LARs. Aside from the Outer Loop, these roadways have not been started yet, so there is a tremendous amount of initial work to be done.

Mr. Daugherty said 20% of construction funding will be available from TxDOT for engineering and ROW (Right of Way) when the environmental clearance process begins. In the first five years, the pre-construction tasks are feasibility, alignment, environmental, public involvement, design, ROW purchase and utility relocation.

According to the Planning Board, it is urgent that freeways be planned now to prevent closing of corridors by development and ROW corridors be acquired as soon as possible at the lowest cost possible. It is extremely important that the County be in the position to fund the tasks necessary to get all of the freeways ready for construction as soon as possible.

The assumptions for the corridors include US380 west of US75 to be along the existing alignment, and the east side would be an extension of Spur 399. The north/south roadway in the southeast part of the County which COG refers to as the Lake Corridor would be from SH121 in the north to the President George Bush Turnpike at the south end. There is also an assumption that there will be an east/west corridor from SH78 between the lakes. The alignment for this has not yet been determined.

Another assumption is that 20% of the UTP funds for US380 will be applied by COG/TxDOT for engineering and ROW for the Spur 399 Extension. Mr. Daugherty is not sure if more than one project can be done at a time. The County will have to provide engineering and ROW funding for the remainder of US380, the Lake Corridor, and the east/west (SH78) corridor. The County will provide ROW funding for all of the Outer Loop. With those assumptions, it is estimated the County will need to contribute \$536 million.

Regarding timelines, the Spur 399 Extension should be approved to start the environmental process in late 2017 and will require an additional \$34 million from the County beyond the 20% from COG/TxDOT. The Lake Corridor should also be approved to start the environmental process in late 2017 and, since this is an extremely long road, would need an additional \$121 - \$191 million from the County. The Outer Loop service road will be ready for construction in 2018 and will require an additional \$9 million from the County. ROW for the Outer Loop between Preston Road and US75 will be ready to start being acquired in 2018 for an approximate cost of \$50 million. While these other projects are going on, the environmental process for US380 west of US75 should be ready to start in early 2019 at a cost of \$157 million.

Mr. Moore said the Planning Board's recommendation is to include a bond election at the maximum amount of funding that will not increase the tax rate for the County. There are three options for how that money can be allocated. They are: (1) 100% of the funding available for LARs; (2) 90% for LARs and 10% for arterials connecting to the LARs; and (3) 80% for LARs, 10% for connecting arterials connecting and 10% for 50/50 sharing of city thoroughfares.

If the Court decides a bond election would be advisable in November, Mr. Moore presented a bond election schedule. The Court would call a bond election on June 30. July 1 would begin voter education meetings with the Public, Planning Board and Commissioners' Court. Promoting voter turnout for the bond election would begin August 1 and the bond election would be held on November 7.

Commissioner Webb is fully supportive of this but is concerned about Spur 399. If the approval of Spur 399 is not tied to US380, then US380 could be stonewalled or blocked. The Commissioner has been assured that more than one project can go forward at the same time. If there is consensus, it can be brought to the RTC (Regional Transportation Council) for approval. Originally the Commissioner wanted all the funding to go toward the freeways, but after talking to the cities he would be supportive of the 80-10-10 option. He would like to see more go to the LARs because he thinks we will not get enough money from the state within the time periods that we need to move these projects along. The County and its taxpayers are going to have to move forward if we want to accelerate these projects and get them built in a timely manner.

Commissioner Fletcher agreed with the 80-10-10 option with the caveat that the 50/50 sharing projects need to be part of our own transportation plan in easing congestion in the County. The Commissioner said something has to be done outside of the LARs because when a major accident shuts down the LARs, people will then go into the cities and need the ability to move through the cities.

Commissioner Williams said some information the Court received after COG did their studies indicated there would be only two additional LARS – the Lake Corridor and the Outer Loop. That would mean the other proposed LARs would be considered principal arterials. The Commissioner said all of the proposed LARs are crucial and integral to each other. Judge Self agreed that SH78 north and south is considered a thoroughfare by the RTC. Commissioner Williams suggested if the 80-10-10 option were selected, that the 80% be used on the SH78 corridor even though it may not be designated as a LARs. The Commissioner wants to be very clear and specific with the terminology. A lengthy conversation ensued.

Judge Self said we are in danger of losing our LARs concept altogether and agreed with Commissioner Webb that the \$500 million could be absorbed in no time. There is a definite disconnect between consensus and cost sharing. No one can anticipate the intensity of the lobbying the commissioners will receive to build city streets. For this reason the Judge said the money needs to be bound. We are in danger of losing control of this because the city staffs want money to go to the cities, and building the six-lane thoroughfares no longer works.

Commissioner Hill said we must have an investment in our infrastructure moving forward, and it is critical that we invest in our LARs and high speed highways. It is critical that our cities invest in city thoroughfares and city streets. The Commissioner is concerned because there are cities that refuse to lower their tax rate, are fighting with the County, and making false statements in Austin about the County's tax rate and services. As they are making these bold proclamations against the County, they are sending us letters asking for money for their cities. We owe it to the taxpayers and citizens to build the infrastructure, but it is frustrating to get those letters at the same time that they are taking swipes at the County in a way that is misleading and false. The Commissioner is not against helping cities with their thoroughfares, but they come lower on the priority list than the LARs. If we don't put some hard lines around what we intend to get done, we run the risk of losing the focus on the big issues.

Commissioner Williams said SH78 was our number two priority. If it is not going to have access to the 80, 90 or 100%, then that is a non-starter for the Commissioner. Whether the improvements are a LARs or a principal arterial, it is a critical roadway both north/south and east/west and must continue to be a priority. Commissioner Hill agreed SH78 is a priority, but COG's advice was that is not the best roadway to build as a LARs. There was a lengthy conversation regarding SH78.

Commissioner Fletcher said when the Commissioners made their presentations to the cities, we started out with a number of \$400 million and now we're talking about \$535 million. Our whole vision and funding has changed. Will some of the \$535 million be diverted to roads that go through cities? We need to focus on how we will move people throughout the county not whether or not it is within a city border. According to the timeline, we will not be building LARs during the first five years, and we need to think about how we will move traffic through these cities because they will have to handle the congestion.

Commissioner Hill said it is important to give citizens as much clarification as possible regarding how their money will be spent. Judge Self agreed saying it needs to be bound in the ballot language and in the presentations to the citizens. (Time: 7:18 p.m.)
