GENERAL DISCUSSION

5. AI-33858 RTC monthly update, Commissioner, Precinct 4.

Commissioner Webb updated the Court on the latest RTC (Regional Transportation Council) board meeting. The lengthiest discussion related to the legislative session was regarding the CDA (Comprehensive Development Agreements) bill which was voted down in the House. Some options were discussed. The CDA bill has major repercussions on Collin County. Without the bill, most all of the money for the region will be absorbed through the rebuilding of LBJ East. Without state money coming in, the bond issue is even more important in order to move forward with planning and ROW (Right of Way) acquisition for Collin County.

Commissioner Hill asked if the CDA action will impact the billion dollars already allocated to Collin County. Commissioner Webb said it would be impacted. The allocation would still be there, but we would not see any money for at least the first half of the ten year period.

Commissioner Fletcher asked if the Court should have something prepared to send to the Governor regarding this issue in the event there is a special session. Commissioner Webb said that was a possible option being discussed. Commissioner Hill asked if the Governor would put a toll road in any form on a special session call. Commissioner Webb does not think that will happen.

Another big discussion was the timeline on the 2019-2022 Transportation Improvement Program. Between now and January of 2018 the Court will need to continue to move forward with our modeling and decide if we want one or two projects and how to structure it

The next item was the 2045 Demographics Update. Projections show that Collin County has 932,530 residents as of January 2017. The Commissioner questioned this since there were only 540,000 registered voters as of November 2016. COG (Council of Governments) staff is looking to see if that projection is valid. There is a lot of modeling going on for the 2045 Mobility Plan, and if we are off on the population estimates, it could impact the modeling.

Lastly, the Potential Transportation Alternative Program Funds Lapse was discussed. There is approximately \$2.5 million that may lapse, and much of that is Plano's money. The Commissioner talked to them after the meeting, and they believe they can get it done and have that money obligated. (Time: 1:38 p.m.)
