Commissioner Webb pulled this item saying these improvements are necessary, and he does not want to cause a delay. However, the County is working diligently to build consensus on the LARs (Limited Access Roadways) corridors, and the Commissioner would like to make sure the County is not fronting money for cities that are working counter to this. The Commissioner suggested the County fund the entire 10% and structure it as a loan to be forgiven if the cities work with us on the LARs. There is past precedence of paying the entire 10%.

Clarence Daugherty, Engineering, said the Town of St. Paul has passed a resolution opposing the Lake Corridor because of the view. The City of Wylie has not yet officially addressed that specific corridor.

Commissioner Williams said the LARs effort needs to speak for itself, and while the City of Wylie has not passed a resolution in support of the LARs, they have also not opposed it and are continuing to look at it closely. Judge Self liked Commissioner Webb's idea and said the LARs vision is in jeopardy with the opposition from some of the cities. The Judge suggested a forgivable grant. Commissioner Williams is comfortable with a forgivable grant as long as the Court is consistent across the board. Commissioner Webb would like the cities to assist in identifying the corridors and where the actual lines will be, not just passing resolutions in support of the LARs. If a city does not support the LARs, then they would need to come up with their match. After a brief discussion, a motion was made to fund the entire \$1,319,137.40 of the match for the FM 2514 project with the understanding that the monies paid on behalf of the City of Wylie and the Town of St. Paul are in the form of a loan or advance which the County will forgive conditioned upon the cities supporting the County's effort to determine the route for the LARs corridors.
