Commissioner Webb questioned the rationale of awarding the bid to VariVerge because the bid was \$20,000 higher than the other vendor. Michalyn Rains, Purchasing, said this contract has been rebid three times since 2013. Previously a straight bid was conducted which was evaluated on price alone. This time an RFP (Request for Price) was conducted in order to evaluate on factors other than price.

This was due to performance issues with the previous vendors. If the score for price was taken out of the comparison of vendors, VariVerge would have a higher score than the other vendor. The pricing for VariVerge was in line with what they have bid in the past, but were never given an award due to evaluations on price alone. Purchasing worked closely with the Tax Assessor/Collector staff to clear up specifications and expectations. The Tax Assessor/Collector has confirmed they have the funds in the budget to cover the additional amount. With no further discussion, a motion was made to approve the item. (Time: 1:34 p.m.)
