The Texas Juvenile Justice Division (TJJD) staff have reviewed the diversion application, 17-D0271, for PID # 22976. This application has been **approved** for diversion. TJJD has approved placement at G4S – The Oaks at a daily rate of \$185 for 60 days and \$162.30 for 120 days. TJJD must approve any changes to this plan for your department to receive reimbursement.

Fill out the verification and send it to Ashley Kintzer (ashleykintzer@tjjd.texas.gov) once the youth is ordered by the court and placed so that the placement and aftercare treatment information can be confirmed.
