Judge Self asked how the plan is funded. Ms. Kemp said it is funded through a \$5.00 records management fee on documents filed in her office. Judge Self opened the public hearing at 1:35 p.m. Hearing no comments, he closed the public hearing at 1:35 p.m. With no further discussion, a motion was made to approve the item. (Time: 1:36 p.m.)

**6.** <u>AI-38983</u> North Central Texas Council of Governments (NCTCOG) Executive Board monthly update, County Judge.

Judge Self gave an update on the last NCTCOG (North Central Texas Council of Governments) Executive Board meeting. He said the budget grew by \$2 million and NCTCOG added 17 employees. Five were added in transportation which added a significant increase in grants. Six were added for the Regional 9-1-1 Program at an increase of only \$19,000. The Judge questioned how they added six people with only \$19,000, but did not receive a good answer. NCTCOG is a grant driven organization, fees from cities and counties do not cover much of the budget. It was also mentioned that healthcare increased 16%. The Judge questioned what that meant and it was revealed that NCTCOG pays 100% of their employees' healthcare costs. He polled the members of the Board and most pay 20-24% of employee healthcare. He called for a review of this for next year. NCTCOG includes LiDAR (Light Detection and Ranging) in a yearly photometric contract. The Judge suggested they consider doing it every five years instead of yearly because it does not change much and is expensive. (Time: 1:39 p.m.)
