Based on this latest letter from the state the installation of the new AFIS system has been delayed from an August 1st go live date to a September 5th date. Since the state will likely not have Collin County converted to the new AFIS system by October 1st, and we will continue to use the existing AFIS system, we will have to pay for the maintenance renewal on our existing plan. Once we do go live on the new system then NEC will issue a refund to Collin County for the unused portion of the maintenance renewal. I will coordinate with the Auditor's office to have the refund deposited back into the maintenance account. For example, if the county is live on the new system by December 31st then we would receive a refund for 9 months of service, January through September, that we will not use.
