Marie McDaniel, Sachse, came forward to express concern over funding cuts to the AgriLife Extension Services personnel which oversees the Master Gardeners class. Ms. McDaniel is a participant in the class and fears her class may be the last of its kind due to the cuts in funding. The Master Gardeners class in an excellent program that involves citizens who volunteer 65 hours per year to continue gardening in the space provided at Myers Park after the completion of the program. This program is one of the few around that allows children to be involved which is a great opportunity for families. Ms. McDaniel asked the Court to not cut the funding.

Judge Self explained the Court does not set the budget for the Extension Service. The County subsidizes a portion of the salaries for the agents. The agents will be receiving the same salary, but the Extension Service will be paying more if the Court lowers the subsidy. There should not be a decrease in programs due to the change.
