Council) board meeting. The Commissioner reviewed several of the action items approved at the meeting. Funding recommendations for the Transit Administration call for projects was approved. None of the recommended projects were in Collin County. He is unsure of the reason why McKinney's urbanized area was not eligible. The next item was the Congestion Mitigation and Air Quality Improvement Program/Surface Transportation Block Grant Program. This is the local bond partnership program between the cities, counties and the federal government. Collin County does not have any bond dollars available or projects shovel ready to be eligible. Almost \$80 million federal dollars were awarded to the City of Dallas, Hunt and Parker Counties. Commissioner Webb talked with Clarence Daugherty, Engineering, about the possibility of finding projects next year if a bond program is approved in order to be eligible for the federal dollars.

Projects were approved to submit to the 2017 INFRA (Infrastructure for Rebuilding America) Grants Program. The RTC submitted the following projects: 1) IH635 East for \$165 million; 2) the DFW Connector at IH635 and SH114 or SH121 for \$65 million; and 3) the IH20 Y-Connection for \$100 million. Similarly, the projects submitted for the "Big Projects" in Texas and the Dallas-Fort Worth Region were: 1) IH635 East; 2) the IH20 Y-Connection; and 3) a replacement for the Trinity Parkway situation. The RTC requested the federal government continue to formula allocate all the funds.

There was a workshop on Mobility 2045 with several presentations. If Collin County is going to put lines on the map for Mobility 2045 the County will need to get consensus between now and January 2018. Final recommendations will come out in January or February with the action item in June.

The Commissioner was appointed to the Bylaws Committee and will serve as Vice-Chairman.

Judge Self referred back to Mobility 2045 and told Engineering to include the amount of funding, which was little, the County has received last year from the RTC in the presentation. (Time: 1:37 p.m.)
